Purpose

The purpose of this memo is to provide an update on the recommendation for the acquisition of instructional materials that will be presented to the Board of Education for action on August 16, 2022.

Background

One of the areas of instructional work we are exploring for SY22-23 is to design innovative ways for schools to engage each District 97 student and family in setting individual, standards-based learning goals. The department seeks to ensure that we support the provision of academically challenging, research based, culturally responsive, relevant and updated instructional materials closest to where learning occurs - with students and teachers in our classrooms - that considers the following:

- Responsiveness to the work of our teacher teams and the consensus built around the curricular resource adoptions as a result of the resource review process and subsequent pilots.
- Continued alignment of curricular resources between Brooks Middle School and Julian Middle School
- Alignment between the world language departments in the district's elementary and middle schools
- Acknowledgement of the impact of the global pandemic on student learning and achievement
- The connection of the acquisition of curricular resources to the district's learning around the Universal Design for Learning Framework as well as the Danielson Framework for Teaching

Recommendation

Below are the updated recommendations for each curricular resource that was presented at the April 26th Board of Education meeting; the current status of the recommendation; the cost of the resource and the rationale for placing a hold on the recommendation alongside actionable next steps, if applicable:

Rationale and Actionable Next Steps: Given Lucy Calkins current reconsideration of the Units of Study, we are not yet positioned to recommend this resource for adoption. The department remains committed to ensuring that students have access to engaging, culturally responsive, complex texts that support many of the <u>key</u> common core shifts in text complexity; grounding reading, writing, and speaking in evidence from texts; and building knowledge through content-rich nonfiction. Therefore, we are recommending that a system is designed that allows teachers to request texts for students easily and quickly based on the design of standards-aligned lessons and units.

resource. To that end, we are seeking to expedite the review process and prepare for a comprehensive resource							
review and pilot process.
