Executive Advisory Board Meeting June 5, 2024 9:00 AM

The Mid-Valley Special Education Cooperative Board met in Regular Session on Wednesday, June 5, 2024, at the Mid-Valley Special Education Cooperative, 1304 Ronzheimer Avenue, St. Charles, IL 60174.

Call to Order

Dr. Gordon, Superintendent D303, Board Chairman, called the meeting to order at 9:01 a.m.

Roll Call

Upon roll call the following members were also present: Mr. Kim, Superintendent D101; Mr. Potsic, Representative for D301; and Dr. Leden, Superintendent D302. Dr. Barrett, Superintendent D304, arrived after Roll Call and the Approval of the Agenda at 9:02 a.m. Absent was Dr. Mongan, Superintendent D301.

5.1 Student Enrollment and Classroom Space Update

Mrs. Palese provided the 2024-25 school year projections and compared them to the 2023-24 school year projections. As of 5/31/24 there are a projected 272 program students and 94 students receiving hearing services for a total of 366 students projected for the beginning of the 2024-25 school year. Mrs. Palese also gave the projected numbers for how many students were in each program, each class and the number of available openings, if any.

5.2 2024-25 Staffing Update

Mrs. Palese reported the number of filled staff positions as well as the number of vacancies needing to be filled for the start of the 2024-25 school year.

5.3 Celebrating SEA and SAIL

Mr. Ackerman shared some of the successes for the SEA and SAIL programs. This year there were 15 students that graduated from SAIL and 4 from SEA. 19 new students will start in the fall at SAIL and 9 at SEA. Mr. Ackerman expressed thanks and gratitude for allowing another case manager for the SEA program that will be starting this fall. He also expressed what a great team he has and how they are the reason for the success of the evolving and expanding programs.

For Discussion

6.1 Mid-Valley Services for Multilingual Students

Mrs. Palese gave information to the Board regarding ELL services for Mid-Valley students. This is a challenging task since district team members provide services to their own students who could be at any of the 5-member district schools. It would be more practical and beneficial for a Mid-Valley team member to be able to provide direct services to students who are identified as needing this level of service. Mid-Valley would like to develop a committee of EL Directors and Special Education Leaders to work together next year to design a more comprehensive plan for the future. For now, Mid-Valley is asking to add an additional half day to a .80 FTE staff member who is able to provide these services until a set plan is in place. The Board members were in agreement, and this will go as an Action item at the next Board Meeting.
