RE: Assistance with Dropout Prevention

Introduction:

Students leaving school prior to the completion of a high school diploma continues to be a challenge for the San Carlos Unified School District. Indeed, we still estimate that 40 percent of an age cohort fails to graduate from high school. While the drop out problem within Native America is well known, it is most impacting on the rural reservations and contributes to high crime rates and unemployment.

The district has funding to provide tutoring, evening classes, and supplemental support to students. However, students in 8th, 9th, and 10th grade fail to access these opportunities. As a result of poor attendance, lack of immediate relevance of a class to the student's life, and minimal parent involvement, nearly 50 percent of the students in grades 9 and 10 fail four or more classes. The attendance pattern of student established by 8th grade continues to be the attendance pattern in high school. Thus, the dropout rate is determined in the first two years of high school simply because a student fails so many 9th and 10th classes, making it impossible to graduate with his or her class.

Intent of this Request:

The intent of this request is to acquire funding to create direct incentives for parents (and therefore indirectly for students) to achieve in school. Specifically, this request targets parents of 8th, 9th and 10th grade students (to provide incentives directly to the parents) for students in the grade levels most closely aligned to the dropout rate.

The Request:

We are requesting funding to purchase from businesses located on the reservation, gas or food gift cards. The following charts define the fiscal support request:

Mission: Empower graduates with skills to be 21st century Nnee

Goal: Will graduate 95% or more of its students with 21st century skill

Vision: With parents and tribe as partners, 80-85% of San Carlos Unified School District students in three to five years, will graduate having met all state assessment expectations

Parents of students in 8th, 9th and 10th grades would receive

- 1. Each quarter a student has 95 percent attendance to all classes the parent would receive a \$25 gift card for participating business of their choice for food or gas. The maximum this could cost is \$5,750 per quarter for a total of \$20,250.
- 2. To encourage other students to improve their attendance, the parent of any student in 7-12 with ninety percent attendance for the year and all passing grades for both semesters would receive a \$50 gift card from a participating business of their choice. The maximum cost would be \$27,500.
- 3. The parents of students in grades 8, 9, and 10 whose child receives a B average at semester grading (January & June) would receive a \$100 gift card from a participating business of their choice. The maximum cost would be \$27,000 per semester and \$54,000 for the year.
- 4. Parents of students in grades 8, 9 and 10 whose child passes both AIMS Math and AIMS Reading would receive a gift card for \$150 from a participating business of the parents' choice.
