Bus service is provided to families that live 2 or more miles from their zoned campus.

Bus services is not provided to families on a transfer.

Some bus services are provided to families that live within the 2 mile radius due to hazardous routes that exist in the path of student walking.

218 regular bus routes existed for the 24-25 school year.

92 hazardous routes existed for the 24-25 school year.

91 hazardous routes will be in existence for 25-26 school year.

For 25-26 some elementary hazardous routes have changed in school name only due to retirements.


Heritage Elementary / Highland Village Elementary Retirement Bus Service






Ethridge Elementary Bus Service due to boundary adjustments
