From: Margo Empen, Superintendent & Marc Campbell, Chief School Business Official RE: Resolution for the Expenditure of Funds Prior to Adoption of the FY 2026 Budget

Illinois School Code does not require a budget be adopted by the Board of Education until the end of September, which is the end of the first quarter of each fiscal year. Although there is no statutory requirement for the authorization of spending prior to that date, it is imminent that spending will be required in that three-month period. School districts may adopt a best practices solution by adopting a resolution allowing the superintendent or designee to manage contracts, expend funds owed and make necessary purchases in advance of the formal budget adoption. Dixon Unit School District #170 did adopt such a resolution prior to the beginning of the last fiscal year.

The attached resolution gives that spending authorization to the superintendent or designee and eliminates any uncertainty as to whether any required spending is permitted by the Board of Education. This will not be any change in payment or purchasing practices other than ensuring that there is proper authorization.

It is the recommendation of District Administration that the attached resolution be approved at the June 25, 2025 Board of Education meeting.

DIXON UNIT SCHOOL DISTRICT 170 RESOLUTION FOR THE EXPENDITURE OF FUNDS PRIOR TO ADOPTION OF FY 2026 BUDGET

- WHEREAS, the Board of Education for Dixon Unit School District 170 ("Board of Education") is the governing board of Dixon Unit School District 170, Dixon, Illinois;
- WHEREAS, pursuant to Section 17-1 of the Illinois School Code (105 ILCS 5/10-22.8), the Board of Education is required to pass a budget by the end of the 1st quarter of the fiscal year, on or before September 30th of each year;
- WHEREAS, pursuant to Section 4:60 of the Board Policy Manual for Dixon Unit School District 170, adoption of the annual budget authorizes the Superintendent or designee to purchase budgeted supplies, equipment, and services, provided that State law is followed;
- WHEREAS, also pursuant to Section 4:60, of the Board Policy Manual for Dixon Unit School District 170, the Superintendent or designee shall manage the District's purchases and contracts in accordance with State law, the standards set forth in this policy, and other applicable School Board policies;
- WHEREAS, also pursuant to Section 4:60, of the Board Policy Manual for Dixon Unit School District 170, the Superintendent or designee shall manage the execution of District contracts; and
- WHEREAS, there are purchases required to be made and funds to be expended prior to the formal adoption of the annual budget for Fiscal Year 2026 so that the schools are ready for opening, personnel are paid and other services and supplies are purchased;
- **NOW THEREFORE, BE IT RESOLVED** by the Board of Education for Dixon Unit School District 170, Lee and Ogle Counties, Illinois as follows:
- Section 1. The Board of Education hereby finds that all of the recitals contained in the preambles to this Resolution are true, correct, and complete and does hereby incorporate them into this Resolution by reference.
 - **Section 2.** This Resolution is in full force effective July 1, 2025.
- Section 3. The Board of Education authorizes the School District's Chief School Business Official to purchase items or enter contracts on its behalf prior to adoption of the Fiscal Year 2026 annual budget.
