Board of Directors Meeting

March 12, 2025

The Board of Directors meeting covered several key points. The district's financial health was discussed, noting a projected 13% fund balance and the importance of maintaining a 5-15% fund balance. The board approved the 2025-2026 budget calendar and extended the superintendent's contract. Public input emphasized the importance of CTE programs and potential collaboration with Trajectory for forestry education.
