602 Organization of School Calendar and School Day

• Committee Discussion: Updated language

Section III(A): "The school calendar shall be adopted annually by the school board. It will meet all provisions of Minnesota Statutes, section 120A.41, and all other provisions of law pertaining to minimum number of school days. The school calendar shall establish a minimum of 167 days of instruction for students in grades 1 through 11, a minimum of 1028 hours of instruction for students in grade 12, workshop days for staff, provide for emergency closings and include other information relevant to students, staff and parents." Section V(A)(1-4):

- 1st inclement weather/snow day= a snow day for all staff/students, it will not be rescheduled or require the use of an e-learning day;
- 2nd inclement weather/snow day= a snow day for students and a professional development day for staff;
- 3rd inclement weather/snow day= an E-Learning day for all students and staff; and
- ISD 200 may designate up to five e-learning days in one school year
