Denton Independent School District Additional Classroom Display and A/V Refresh Project Purchase

SUMMARY:

This item requests approval of the invoice from ProComputing Corporation in the amount of \$11,050.00 for the purchase of two additional interactive panel displays for McMath Middle School.

BOARD GOAL:

Growth & Management - Demonstrate effective and efficient management of district resources

PREVIOUS BOARD ACTION:

The Board called for the 2018 bond election with the recommendation by the Bond Committee. On May 5, 2018 the bond was approved by the voters of Denton ISD.

On December 10, 2019 the Board approved the purchase of the Classroom Display and A/V Refresh Purchase in the amount of \$6,779,876.00.

BACKGROUND INFORMATION:

The original request for purchase was based upon the replacement of 1,262 classrooms. During the install at McMath Middle School, it was determined that two additional classrooms were in need of the interactive panel displays. These additional panels were installed by the vendor without an approved purchase order in place. The addition of these two interactive panel displays brings the replacement total to 1,264 districtwide.

SIGNIFICANT ISSUES:

Denton ISD has approximately 1,264 classrooms with outdated projectors some of which are more than 12 years old. These projectors lack modern features such as interactivity at the board as well as allowing for teacher and student devices that support new pedagogies. The older projectors also lack management capabilities that provide remote support tools, remote shutdown capabilities and ability to push out device patches and security updates.

The projector bulbs for these older models are expensive to purchase, burn out quickly and are becoming increasingly more difficult to purchase.

The classroom display and A/V upgrade solution will be purchased through a Texas Local Governmental Purchasing Cooperative (TIPS). This purchase is being brought for approval in accordance with the District's CH (local) policy.

FISCAL IMPLICATIONS:

The cost will be borne through the 2018 Bond Authorization – Projector/Audio Visual budget in the amount of \$5,419,050. The remaining amount of \$1,371,876 will be funded from the 2018 Bond Authorization – PA System budget.

The approval of this purchase will allow the District to move forward with the Promethean ActivPanel as a standard for the District Interactive Display solutions. This purchase will help bring interactive equity to all campus classrooms.
