2015-2016 Budget Discussion Debbie Monschke, Asst. Superintendent for Administrative Services reviewed the 2015-2016 revenue projections and budget changes.

Discussion and Review of Campus Enrollment Capacity

Dr. David Hicks, Exec. Director of Secondary Academic Programs provided the trustees with projected enrollment and reviewed the administrative regulations that guide the intra-district and inter-district transfer process. Administrative regulations make the transfer process more transparent and accessible to parent. Monitoring enrollment growth and campus capacity allows principals to accept transfer students in advance and to use campus resources effectively and efficiently. Elementary enrollment projection dictated that each year it will grow by 1-3 percent of current enrollment at Cross Oaks, Savannah and Pecan Creek, which are high-growth schools. All three comprehensive high schools are currently exceeding functional capacity. Campuses that currently have capacity for transfers for the 201516 school year: Borman Elementary, Cross Oaks Elementary, Evers Park Elementary, Ginnings Elementary, Hodge Elementary, Lee Elementary, Rivera Elementary, WS Ryan Elementary, Stephens Elementary, Calhoun Middle, McMath Middle, Denton High (only for IB).

Legislative Update

Superintendent Dr. Jamie Wilson led the Board in a discussion of the latest actions of the 84th Texas Legislature. He called attention to a senate bill that will require the education commissioner to calculate ADA for Flexible School Day.

The House Public Education Committee passed a bill that would create the Texas Opportunity School District, and require the commissioner to determine, after a campus has been identified as unacceptable for two consecutive school years, whether the district has instituted meaningful change, including reconstituting the staff or leadership at the campus.

Due to the governor's approval of HB 4 this week, districts are formulating processes and committees to determine the appropriate course of action to allow a student to graduate even though they may not have passed all End-of-Course (EOC) exams. Under this new provision, a teacher's perspective of a student's performance in class takes precedence over a student's performance on the STAAR EOC.
