**NSBSD Policy Manual:**

Board Policy 3312, Contracts: The Superintendent of designee may enter into contracts and memoranda of agreement (MOA's) on behalf of the District. All contracts and MOA's with a dollar value of \$50,000 or greater must be approved by the School Board.

**Issue Summary:**

Based on State and federal law, NSBSD is required to have speech-language pathologists available to screen, evaluate, provide services, and consult with school staff to support students with speech-language needs. Individual and/or small group speech services may be provided in person or remotely based on the Individualized Education Plan. To determine if a speech disability exists, the speech pathologist has input in the following meetings: pre-assessment meetings to explain assessments being used, Infant Learning Program 90-day transition meetings, initial evaluations, re-evaluations, and IEP meetings.

**Background:**

NSBSD staff as required by the Individuals with Disabilities Act (IDEA) and Board Policy 6164.4. Ms. Hunnemeder is an Alaska-licensed speech pathologist who implements speech evaluations and services. She has been an independent contractor for the Craig City School District and Nome Public Schools and is familiar with school-based speech services. Ms. Hunnemeder will continue to service Barrow High School, Hopson Middle School, Kali School, Alak School, Meade River School. Ms. Hunnemeder has experience providing remote speech services and training to special education staff. Her experiences include attending pre-evaluation meetings and explaining assessments to parents, attending Infant Learning Program 90-day transition meetings to determine school-based assessments, conducting initial and re-evaluation, writing IEP goals, and attending IEP meetings.



**Length of Contract:**

FY 27

**Funding Source and Contract Amount:**

NSBSD will fund this MOA through the general fund and the VI-B Special Education Grant. The Contractor will be paid \$850 /day for up to 170 days (\$144,500.00) for professional services (With the addition of BHS and HMS the number of days have increased by 43 days. Ms. Hunnemeder’s travel will be reimbursed for up to 2 trips from Honolulu, Hawaii to Utqiagvik, Point Lay, Wainright, Tikiqag School, and Atqasuk. Travel expenses are not to exceed \$6,000.00. Total MOA not to exceed \$150,500.00. There are no NSBSD benefits associated with this MOA. Ms. Hunnemeder currently has an MOA with Nome Public Schools. With the Nome MOA is in place, travel expenses from Honolulu, Hawaii to Anchorage will be funded at 50% per school district for concurrent travel.

**Grant Funding:**

This MOA is funded through the Title VI-B Special Education grant (285. 200.220.000.410) and the NSBSD general fund (100.200.220.000.410).

**Compliance with BP 3311.**

Ms. Hunnemeder has Alaska bush experience through her experiences working in Craig City School and Nome Public Schools. Based on Ms. Hunnemeder’s experience, this rate is within the acceptable range of rates paid across the state of Alaska. In support of the approval of a sole-source MOA, this contractor will require limited training and a minimal adjustment period to provide speech/language services and training to our staff.

**Recommendation:**

The Student Services Department recommends passing this MOA. Services are state and federally mandated under IDEA and are required to meet the educational needs of students with a speech/language disability.

Contractor Agrees To:

As Case Manager, administer and complete initial speech evaluations, re-evaluations, or file reviews for student(s) with speech/language concerns or needs. Maintain on-going contact with Student Services Staff to support the parent and student during program development and implementation.

Transfer speech/language assessment data to the ESER/IEP through the district web-based system. Participate on-site or via distance in federally mandated pre-assessment planning meetings, 90-day transition meetings, initial evaluation meetings, re-evaluation meetings, IEP meetings, as needed.

Provide continued support and services to eligible students at Tikiġaq School, Kali School, Alak School, Meade River School, Hopson Middle School, and Barrow High School. School sites may change based on student and NSBSD needs.

Support the SPED teachers with the development and interpretation of annual speech/language goals and objectives.

Provide speech/language training and consultation to teachers and paraprofessionals for program implementation, technology support, and materials development.

Collaborate with the Student Services Office to develop processes, procedures, and possible Board Policy for the implementation of distance related services.

Complete quarterly progress reports as required by state and federal law. Maintain contact with case managers, related service staff, and Director of Student Services, as appropriate.

Support the SPED teacher in completing the required COSF (Child Outcome Summary Form) for pre-school students eligible for special education or speech services.

---

Support SPED teachers with hearing screenings for special education students, as required by law, for initial referrals and re-evaluations.

---

Maintain confidentiality of student(s) information as per NSBSD Board Policy, State, and Federal laws.

---

Coordinate with school staff to develop a schedule for dates of travel and remote service delivery. Collaborate to ensure services and student evaluations are completed on time as outlined in the IEP. Submit a travel schedule to the office of Student Service at least 3 weeks in advance for final approval and processing.

---

Upon request, complete and submit a background check. Disclose to the Student Services Office of any disbarment or AK licensing issues. Maintain up to date insurance, AK Business License, speech/language therapy license.

---

Notify the Student Services Office if services are unable to be provided as scheduled. For planned time off, alternative services delivery options are to be provided to the SPED staff or make-up services are to be scheduled.

---

It is the responsibility of the contractor to monitor workdays approved within the timeline of the approved contract. Contract days are to extend from students first day of school through the end of the school year based on the NSBSD Board approved calendar

---

Contractor agrees to have the technology necessary to implement the required activities of this MOA. This includes a minimum of a laptop, scanner, zoom, etc. Provide NSBSD monthly invoices outlining days worked by date.

---

During the ESY period, if students qualify, Contractor Agrees To: Provide distance speech services to students as outlined in the student's Extended School Year IEP.

---

Contractor Agrees To: Keep records of student's attendance and progress during the period and provide a summary report to the Students Services Office.

District Agrees To: Reimburse CONTRACTOR for expenses directly and necessarily incurred in relation to the performance of service under this agreement. Travel expense reimbursement will include the cost incurred by the CONTRACTOR to travel to/from Honalulu, Hawaii to NSBSD villages as necessary during this Agreement.

---

Travel expenses will include the cost incurred by the CONTRACTOR to travel to/from Honalulu, Hawaii **to/from, Utqiagvik, Wainright, Point Lay, Tikiġaq, and Atqasuk up to two times per year.** Hotel reservations may be made by NSBSD but paid for by the Contractor. Travel expenses not to exceed **\$6,000.00**. Change fees shall be paid if changes are made at the direction or request of the district.

---

Provide lodging, whenever possible, in Utqiagvik and NSBSD villages.

---

Pay the contractor **\$850 per day for up to 170 days** of professional services.

Payment Terms: Net 30 days upon receipt and approval of Contractor invoice.

**A – GENERAL INFORMATION**

1. Per Board Policy 3312, MOAs for more than \$50,000 require prior School Board approval before Contractor provides any service.
2. All MOA’s more than \$10K will be presented to the School Board for information purposes.
3. All associated costs, not limited to fees and reimbursable, must be included in the MOA.
4. The account to be charged must be determined and approved by the individual with budget authority prior to submission of the MOA to the Director of Finance or their designee.
5. Prior to the starting date of the contracted services and/or activities, the Contractor and the NSBSD must sign the MOA. The Contractor is not to be given a notice to proceed unless all the appropriate parties have signed the MOA.
6. The District Contact will be responsible for obtaining the contractor’s signature and submitting the original MOA to the Director of Finance or their designee
7. The District Contact must approve for payment all contract invoices and receipt documentation prior to submission for payment to the Director of Finance or their designee.
8. When the MOA involves travel paid by the NSBSD; a Travel Requisition must accompany any invoice.
9. MOAs cannot be used for NSBSD employees.
10. Any NSBSD employee who authorizes services prior to the required approvals may be subject to disciplinary actions up to and including termination. (BP 4118 and 4218)

**B – CONTRACTOR RESPONSIBILITIES**

1. Check the MOA for contents and completeness. If the terms are agreeable, sign the agreement and return to the individual named has the Contact Person.
2. The contractor warrants that where the service requires it , the contractor will carry the required certification for the service and will provide proof of certification with the executed agreement.
3. The contractor agrees that all work products created in the course of the agreement remain the property of NSBSD.
4. The Contractor agrees to uphold confidentiality of all parties associated with this Agreement as outlined in NSBSD Board Policy, State, and Federal laws.
5. Contractor agrees to provide the necessary information to allow NSBSD to complete a district-approved background check of Contractor. Passing of the background check is contingent to the execution of this agreement. NSBSD reserves the right to request a background check at any time throughout this agreement.
6. Contractor will follow the professional code of ethics as defined by National Standards and the State of Alaska Code of Ethics for their area of certification and/or licensing.
7. In accordance with the payment terms set forth on page 1, the Contractor shall submit an invoice with the appropriate documentation (copies of airline tickets, hotel bills, etc.) to the Contact Person for approval of payment. This Purchase Order number must be on the invoice.
8. As a condition of performance, the Contractor must pay all federal, state, and local taxes incurred by the Contractor.
9. A W-9 must be on file with the NSBSD Business Office or submitted with this MOA. If no W-9 is provided, backup withholding of Federal taxes will be withheld as required under federal law, which is presently 29%.

10. The Contractor must provide proof that all required certificates of insurance listed on page 1 of this MOA are current for the term of the contract.
11. The contractor must maintain a current Alaska Business License for the term of the contract.
12. To the extent allowed by law, the Contractor shall indemnify, defend, and hold the NSBSD harmless from any liability resulting from or arising out of the acts of the Contractor in the performance of this MOA.

**C – GENERAL TERMS**

1. This contract may be terminated by either party with a 30-day written notice.
2. Contractor, is an independent contractor. As an independent contractor, Contractor shall have no right or authority to (a) assume or create any obligation of the District; (b) accept service of legal process addressed or intended for the District; or (c) bind the District in any manner whatsoever. Contractor shall not be treated as an employee for purposes of employment taxes, income tax withholding, or employee benefits. Contractor is solely responsible for the payment of all applicable federal and state self-employment and income taxes (including without limitation FICA and Social Security).
3. This MOA shall be governed by Alaska law.

I HEREBY ACCEPT THIS MOA AND THE CONDITIONS/PROVISIONS CONTAINED HEREIN.

Any changes in the terms of this MOA must be on an ADDENDUM FROM prior to any services being performed. The ADDENDUM FORM must be approved by all parties.
