


Interpreting The Charts

- Subgroups percentages are reported only if there are 10 or more students. 0% indicates there were less than 10 students with scores in that subgroup for that year


High School PSAE Reading




High School PSAE Math




Middle School ISAT Reading




Middle School ISAT Math




6th Grade ISAT Reading




6th Grade ISAT Math




5th Grade ISAT Reading




5th Grade ISAT Math




4th Grade ISAT Reading




4th Grade ISAT Math

Statewide Data

- 82 percent of Illinois Districts and 66 percent of Illinois schools failed to make Adequate Yearly Progress (AYP) in 2012
 - These numbers reflect slight increases over 2011
 - ISBE is confident that their new waiver request will be approved and that 2012 will be the final year for AYP determinations.
- The statewide composite score for students meeting and exceeding standards on the Illinois Standards Achievement Test (ISAT) stayed nearly flat, going from 82.0% (Meet/Exceed) in 2011 to 82.1% in 2012
 - H122 ISAT composite score was 80% in 2012
- The composite score for the Prairie State
 Achievement Exam (PSAE) increased from 50.5% in
 2011 to 51.3% in 2012
 - H122 PSAE Composite score was 51% in 2012

ISAT 2013

- ISAT Writing Assessment still suspended for 2012
 2013
- The 2013 Reading and Mathematics ISATs will contain items written to the Common Core Standards
 - Approximately twenty percent (20%) of the operational items on the Reading and Mathematics ISATs were written to Common Core Standards and will be included as part of students' scores/results for the 2013 ISAT.

ISAT 2013

- Performance levels ("cut scores") for the 2013 administration of the ISAT will increase in 2013
 - Better gauge of college and career-readiness
 - Better alignment with the PSAE
 - Currently 82 percent of students in the state meet or exceed on the ISAT, compared to 51 percent on the PSAE
 - New cut scores are not yet available

ISAT 2013

- ISBE expects ISAT scores to drop in 2013
 - "We must raise our expectations at the elementary level so that students are on track to leave high school prepared to succeed in the work force, career and daily life. We owe it to our students to better align the ISAT with the rigor and college and career readiness benchmarks of the PSAE." (Chris Koch, State Superintendent)

PSAE 2013

- Grade 11 writing component is still eliminated for 2013
 - Students taking the PSAE this year will not receive an ACT Writing score
 - Students who are seeking admission to universities and colleges that require a writing score on a national examination must take either the ACT or SAT on a national test date and independently from the PSAE that is being administered this spring
- ISBE will be providing a "no cost" opportunity for all students to participate in the 3rd available WorkKeys® assessment, Locating Information, and to earn ACT's National Career Readiness Certificate (NCRC™)
 - Districts are "strongly encouraged" but not required to administer
