Goal/Objective Addressed	Public Education Reform Crosby ISD will support and/or participate in litigation and/or legislative efforts in support of a strong public education system legislative efforts in support of a strong public education system.
Background	<p>Each school year, the Texas Education Agency (TEA) receives and grants many types of state waiver applications, including general and expedited waivers for both basic and detailed information from districts.</p> <p>Crosby ISD currently has waivers in place for Modified Schedule/State Assessment Days, Teacher Data Portal of the Texas Assessment Management Systems, and Foreign Exchange Students. These waivers are current through the end of the 2025 – 2026 school year. The Curriculum and Instruction Department would like to apply for these waivers on the TEA portal through the 2028 – 2029 school year. The waivers are granted every three years.</p> <p>The Modified Schedule/State Assessment Days Waiver allows districts to modify the schedule of classes for students who are not being tested to report to and attend school after the state assessment testing period has ended, therefore reducing the interruptions during testing period. Students who are not being tested must still meet the maximum 2-through-4 hour requirement for funding.</p>

	<p>Teacher Data Portal of the Texas Assessment Management Systems Waiver allows districts to fulfill the requirement of TEC, §32.258 to provide teacher access to student assessment data through a local student data system. Crosby ISD utilizes Eduphoria for teacher access to student data.</p> <p>The Foreign Exchange Students Waiver allows allows districts to limit the number of foreign exchange students to a number that is 5 or more per high school under Texas Education Code §25.001 (e). A request to limit the number to less than five per high school must be submitted as a general waiver application.</p>
