AGENDA ITEM: Consider Adoption of the Hart InterCivic Verity System as the Voting System to be Used for All Forms of Voting in Parker County

BACKGROUND INFORMATION:

- On September 9, 2019, the Parker County Commissioners Court voted to accept the contract with Hart InterCivic for the purchase of a new voting system for Parker County.
- Section 123.001 of the Texas Elections Code requires that “Before a voting system may be used in elections, the authority designated by this section, by resolution, order, or other official action of the authority, must adopt the system for use in the elections.”
- Pursuant to this purchase by Parker County and to comply with the requirement of the Texas Elections Code, the following Resolution to Adopt the Hart InterCivic Verity System as the Voting System to be used for All Forms of Voting in Parker County is provided for your review and consideration.
