Bid results for 2025 Bardwell classroom flooring replacements.

Justification:

In order to continue to make improvements throughout the district in accordance with our 5-year capital improvement plan, we have collected bids for Bardwell classroom flooring replacements.

A public bid opening was held on March 11, 2025. Four bids were received.

Board Policy:

Pursuant to Board Policy 4:60, Supplies, materials, or work involving an expenditure in excess of \$25,000 must comply with the State law bidding procedure, 105 ILCS 5/10-20.21, unless specifically exempted.

Strategic Plan:

This recommendation supports Strategic Goal #2, Operational Excellence that states the following: *East* Aurora School District 131 will align and utilize systems and resources that promote operational excellence, efficiency, and fiscal accountability.

Dear Dr. Halverson:

On March 11, 2025, bids were received for the EASD 131 – 2025 Flooring Replacements project. The project was publicly advertised on February 11, 2025, and a Pre-Bid meeting was held on February 13th. Bids were received for the project's one (1) Base Bid and (3) Alternate bid scopes. Four (4) bids were received. Pinnacle Flooring had an incomplete bid. Please refer to the attached bid results.

The project included scope for select flooring replacements at Bardwell Elementary School. There was additional scope included as an alternate for flooring replacement in classroom 55, but is not recommended at this time. Alternate #1.1 is recommended as existing floor demolition under a separate abatement contract is not required. Below is a summary along with our recommendations for use on the April 21st, 2025, Board Meeting for direction with award of the project.
