Hello Mr. Mijares,

Per our conversation the following are reasons the Band Hall addition at the high school will cost more than that @ CC Winn:

First, there will 1000 s.f. new construction at the high school to achieve the target of 17,000 of area. Estimate cost \$220 per s.f.

Second, it is anticipated the remodel will be more complex at EPHS due to the age of the facility and the limited area of the site, so we are estimating \$200000 more necessary remodel expenditures.

Thirdly, like at the Field Houses, A new fire line, estimated @ \$100000, will need to be brought close to the addition to comply with current codes. This expenditure will not be necessary at CC Winn.

Fourthly, professional fees will be more significant at High School due to the items noted above.
