August 25, 2015

The Collin County Community College District ("Collin College," "Collin," or "District") conducted its regular monthly Board of Trustees meeting on August 25, 2015, in the Board Room, Room 139, Collin Higher Education Center, with Chairman J. Robert Collins presiding. Trustees in attendance were Ms. Stacy Anne Arias, Mr. Andy Hardin, Mr. Mac Hendricks, Ms. Jenny McCall, Mr. Jim Orr, Mr. Adrian Rodriguez, Mr. Larry Wainwright, and Ms. Nancy Wurzman. Other attendees included District President Neil Matkin, Collin College administrators, faculty, students, staff, and community members.

CALL TO ORDER

Chairman Collins called the August 25, 2015, meeting of the Board of Trustees of Collin County Community College District to order at 5:33 p.m. The Board met at the Collin Higher Education Center, 3452 Spur 399, McKinney, Texas 75069.

2015-8-4-1f Faculty, Staff, Administrator and District President's Compensation/Contract Length

BE IT RESOLVED, that the Board of Trustees of the Collin County Community College District approves a budgeted salary and wage increase for faculty, staff, administrators, and the District President of generally 4%, in addition to approved merit, market, equity, compression, and range adjustments.

FURTHER, at the recommendation of the Board Chairman, the Board of Trustees authorizes an extension to the District President's employment contract, resulting in a three-year contract that extends through August 31, 2018.

<u>2015-8-4-2 Approval for the District President to Negotiate and Execute Contract for Operational Management and Evaluation Services Related to the Administrative Services Division</u>

BE IT RESOLVED, at the recommendation of the District President, that the Board of Trustees of Collin County Community College District authorizes the District President to negotiate and execute a contract for operational management and evaluation services related to the administrative services division for a one year period with option to renew for one additional year at a contract cost not to exceed \$270,000 per annum.

On motion of Ms. Arias, second of Mr. Orr, the Board of Trustees of Collin County Community College District unanimously authorized the District President to negotiate and execute a contract for operational management and evaluation services related to the administrative services division for a one year period with option to renew for one additional year at a contract cost not to exceed \$270,000 per annum.

<u>2015-8-4-3 Approval for District President to Negotiate and Execute Contract for Personnel to Serve as Interim Police Chief</u>

BE IT RESOLVED, at the recommendation of the District President, that the Board of Trustees of Collin County Community College District authorizes the District President to negotiate and execute a contract for personnel to serve as Interim Police Chief for a period ending August 31, 2016, with option to renew for one additional year at a contract cost within the Collin College pay scale for Police Chief.

On motion of Ms. Arias, second of Ms. McCall, the Board of Trustees of Collin County Community College District unanimously authorized the District President to negotiate and execute a contract for personnel to serve as Interim Police Chief for a period ending August 31, 2016, with option to renew for one additional year at a contract cost within the Collin College pay scale for Police Chief.

2015-8-4-4 Approval and Adoption of 2015-2016 Budget

BE IT RESOLVED, at the recommendation of the District President, that the Board of Trustees of Collin County Community College District approves and adopts the Fiscal Year 2015-2016 budget as presented in the amount of \$197,573,297 for Current Funds (operating, auxiliary, and grants/contracts); \$17,881,602 for the Building Fund expenditures, and \$16,844,227 for the General Obligation and Revenue Debt Services Funds, the total budget being \$232,299,126 with said funds to be appropriated to the various expenditure accounts as outlined in budget documentation presented to the Board of Trustees.

Interim District Vice President of Administrative Services/CFO Julie Bradley reviewed the proposed budget for 2015-2016. She said it was a balanced budget with expenditures matching budget revenues. Ms. Bradley previously reviewed detailed budget information with the board's Budget and Finance Committee and the full board at the August 18, 2015, special called meeting. A public hearing was held regarding the proposed budget at the August 18 meeting.

Ms. Bradley said the proposed tax rate of \$0.081960/\$100 would result in an additional \$7.6 million in revenue to the college. She said that tax rate is the fourth lowest among community colleges in Texas. In addition, she presented a chart titled Capital Projects Funding Sources 1985-2015 regarding the board's funding of capital projects since its inception. Ms. Bradley thanked the board for being good stewards of the taxpayers' money.

Mr. Orr said that he had voiced concerns about baselining as much money as \$7.6 million, but that he was comfortable with the college's budgetary funding that was in place. Mr. Rodriguez complimented Dr. Matkin and Ms. Bradley for the well thought out presentation on the budget.

On motion of Mr. Rodriguez, second of Ms. Wurzman, the Board of Trustees of Collin County Community College District approved and adopted the Fiscal Year 2015-2016 budget as presented in the amount of \$197,573,297 for Current Funds (operating, auxiliary, and grants/contracts); \$17,881,602 for the Building Fund expenditures, and \$16,844,227 for the General Obligation and Revenue Debt Services Funds, the total budget being \$232,299,126 with said funds to be appropriated to the various expenditure accounts as outlined in budget documentation presented to the Board of Trustees on a vote of eight (8) for and one (1) opposed. Mr. Hardin cast the opposing vote.

2015-8-4-5 Approval of a Resolution Setting the 2015 Tax Rate

WHEREAS, at its meeting of August 4, 2015, the Board of Trustees of Collin County Community College District, voted on a proposed tax rate for 2015, and

WHEREAS, the Board of Trustees of Collin County Community College District held a public hearing on the proposed tax rate for 2015 on August 13, 2015, and

WHEREAS, the Board of Trustees of Collin County Community College District held a second public hearing on the proposed tax rate for 2015 on August 18, 2015, NOW THEREFORE

BE IT RESOLVED, at the recommendation of the District President, that the Board of Trustees of Collin County Community College District approves setting the tax rate for 2015 at \$0.081960, which includes a Maintenance and Operations rate of \$0.078965 and a Debt Service Rate of \$0.002995.

This tax rate will raise more taxes for Maintenance & Operations than last year's tax rate. The tax rate will effectively be raised by 7.46% and will raise taxes for Maintenance & Operations on a \$100,000 home by approximately \$0.00.

President Matkin explained that there was a requirement for specific language and font size related to this item.

Ms. Arias moved that property taxes be increased by the adoption of a tax rate of \$0.081960, which includes a Maintenance and Operation rate of \$0.078965 and a Debt Service Rate of \$0.002995, which is effectively a 7.46% increase in the tax rate. The motion was seconded by Ms. Wurzman and approved on a vote of eight (8) for and one (1) opposed. Mr. Hardin cast the opposing vote.

Mr. Hendricks said the college is not raising taxes, it is healthy, in great financial shape, and no one presented during public hearing to say anything about the college's tax rate. He complimented everyone involved on a great job.

2015-8-4-6 Approval of PBK Architects, Inc. to Provide Master Planning Services

BE IT RESOLVED, at the recommendation of the District President, that the Board of Trustees of Collin County Community College District approves the District President or his designee to negotiate a contract with PBK Architects, Inc. to provide master planning services.

President Matkin discussed Collin County's dramatic population growth, the college's tremendous enrollment growth, and the time that students have to travel to classes, particularly when compared with 10 years ago. He discussed the various locations and properties of Collin College and the potential for growth in Sachse/Wylie, Celina and Farmersville. Planned services have to happen in a carefully planned environment of academics and facilities and that is done through master planning. Dr. Matkin said Texas law says architects cannot give a price unless they are named by the board. He said it does not obligate the board, but it does allow for the negotiation of pricing.

In response to Mr. Wainwright, President Matkin said master planning services take into account academic, technical and other services, resources; look at trends; kinds of growth; company growth; and what services and buildings in what community would serve those needs. Master planning takes all of those things into account and wraps them into progressive, prioritized plan that the board has an opportunity to give input into and discuss before implementing. It is different from the strategic plan, which is the plan where you take those resources and do something amazing and the master plan is putting the resources into place in the first place.

On motion of Mr. Wainwright, second of Ms. McCall, the Board of Trustees of Collin County Community College District unanimously approved the District President or his designee to negotiate a contract with PBK Architects, Inc. to provide master planning services.

2015-8-4-7 Approval of CCCCD Investment Policy and Strategy

BE IT RESOLVED, at the recommendation of the District President, that the Board of Trustees of Collin County Community College District approves the Collin County Community College District Investment Policy and Investment Strategy.

Ms. Bradley said that state statutes require that the Board of Trustees approve the Investment Policy and Investment Strategy annually. The policy and strategy presented are the same as currently in place.

On motion of Mr. Wainwright, second of Ms. Arias, the Board of Trustees of Collin County Community College District unanimously approved the Collin County Community College District Investment Policy and Investment Strategy.

<u>2015-8-4-8 Approval of List of Qualified Brokers Authorized to Engage in Investment Transactions with CCCCD</u>

<u>2015-8-4-11 Approval of Interagency Contract for Banner Software Maintenance with Texas A&M University – Corpus Christi</u>

BE IT RESOLVED, at the recommendation of the District President, that the Board of Trustees of Collin County Community College District approves the Interagency Contract for Banner Software Maintenance and customized Drop for Non-Payment Program through Ellucian with Texas A&M University-Corpus Christi, for the period of September 1, 2015 – August 31, 2016 in the amount of \$387,198.25, which includes \$362,061.25 for software maintenance and \$25,137 for Banner Student Drop for Non-Payment maintenance.

President Matkin explained how the contract saves the college money by participating in the Texas Connection Consortium for which Texas A&M University-Corpus Christi serves as the fiscal agent.

On motion of Mr. Wainwright, second of Mr. Rodriguez, the Board of Trustees of Collin County Community College District unanimously approved the Interagency Contract for Banner Software Maintenance and customized Drop for Non-Payment Program through Ellucian with Texas A&M University-Corpus Christi, for the period of September 1, 2015 – August 31, 2016 in the amount of \$387,198.25, which includes \$362,061.25 for software maintenance and \$25,137 for Banner Student Drop for Non-Payment maintenance.

<u>2015-8-4-12 Approval of Renewal of Rene' Bates Auctioneers, Inc. and MRB Online Auction Groups, L.C. Internet Auctioning Services</u>

Budget Status Report as of 07/31/15

For the month ending July 31, 2015, expenditures exceeded revenue by \$11,222,168. Year-to-date revenue exceeded expenditures by \$23,832,079.

Investment Schedule as of 07/31/15

Investments for the month of July 2015 totaled a market value of \$250,622,182 with TexPool paying .06% and TexStar paying .07%. The U.S. Treasury benchmark was .01% on July 1, 2015, and .08% on July 31, 2015.

DISTRICT PRESIDENT'S AND BOARD ANNOUNCEMENTS

District President Matkin announced the following:

- College faculty and staff are taking part in several local leadership programs this fall and spring. Natalie Greenwell, Nichole Boone, and Kandi Hoye-Nixon will participate in Consortium Leadership and Renewal Academy (CLARA) as part of the North Texas Community College Consortium. Participants in area leadership programs include: Wendy Gunderson, Leadership Frisco; Kari Kimbrough, Leadership McKinney; Brian Lenhart, Leadership Allen-Fairview; and Alan Pixley, Leadership Plano.
- 2. Collin College has been named one of the top community colleges in Texas by www.schools.com. The website pointed to Collin's affordability, as well as its weekend and evening programs, calling the college "a solid fit for working professionals who want to advance their educations." The article also noted the Collin Higher Education Center's partnerships with Texas universities, which allow students to pursue bachelor's, master's and doctoral degrees without the need to relocate.
- 3. The Spring Creek Child Development Lab School passed its yearly inspection from the Texas Department of Family and Protective Services with flying colors. There were no problems to report.

Trustee Wainwright said the youngest of his four children is now a student at Collin College and is extremely excited about her teachers and classes.

He said he was surprised by the lack of feedback from the community and encouraged citizens to reach out to the board as well as to attend the open board meetings and bring their friends and families. She said the professors touch lives without even knowing it, and that her daughter has decided to be a social worker because of those who touched her life at Collin.

Trustee Rodriguez congratulated all of the employees who received promotions and said he was very pleased that the board could give 4% salary increases and adjustments due to the compensation plan changes. He said he was excited to see the college's ad featuring Ben Davis when he and his wife were at a movie recently. After seeing it, her reaction was to turn to him and say "Wow," which made him very proud. He complimented Vice President Vasquez on a job well done.

Trustee Hardin said the audience heard something unusual from him in that he voted against the budget and tax rate. However, his personal feelings were that with the tremendous increase in income that the college had this year; the taxpayers should have had an opportunity to lower the tax rate. He said that was his personal opinion. Mr. Hardin said Collin College is an excellent college and he is very proud to serve and to know everyone associated with the college.
