Speakers who engage in personal attacks or use insulting, profane, threatening or abusive language during any Board meeting shall be ruled out of order by the presiding Board officer and may be escorted from the Board meeting room by District peace officers or security staff. Any concerns or complaints regarding individual District employees, students, or parents must be resolved via the appropriate complaint process, as stated in Board Policy BED (Local). Pursuant to section 551.042 of the Texas Government Code, no Board Member or Administrator may respond to a member of the public regarding an item that is not listed on this agenda, unless such response is a recitation of District policy or a statement of specific factual information.

Clarissa Fraga: Ms. Fraga claims issues being ignored and that she has felt threatened and retaliated against. Ms. Fraga also reminds the board of their duties and responsibilities and states that they are there to "govern".

Leticia Juarez: Ms. Juarez states that she has made open records purchasing requests and suggests that the district provide such requests in excel format and that items should include a description and purpose. Ms. Juarez says that by doing so the district will be more transparent by making it easier for taxpayers to see how monies are being spent. Lastly, Ms. Juarez suggests that the district provide a monthly budget expenditure report "as a regular agenda item" and has provided samples from other districts.

Victor Vazquez: Mr. Vazquez addresses the board and questions why agenda item "Superintendent's Report" would have very little to no information (referring to an informational item).

Keila Sanchez: Ms. Sanchez makes the board members aware how disappointed she was at the new media recording location regulation implementation and states the public

recording from their seats were not causing any disruption but rather that the disruption came from the board (accusing Ms. Oliveros) when attempting to enforce the new guideline. Furthermore, Ms. Sanchez addressed Ms. Oliveros and requested that she stop hiding behind board president Veliz.

Ms. Oliveros replied in disbelief that a member of the community disagreed with the district enforcing this implementation when the person in question has been known to carry weapons on district property. She reminds the public that this facility is a student activity complex. Lastly, Ms. Oliveros stated that she would stand up for herself and students of this District.

Yredh Felizardo addresses the board to express her concern of a No Re-entry policy set in place by the district's athletics department. Ms. Felizardo kindly requests if this can be reconsidered. She says she has many kids and that she would be charged up to three times due to this policy. Ms. Felizardo also informs the board that she has collected parent signatures to show their support to fix this issue.

Ramiro Veliz responds to Ms. Felizardo and assures her that the board will look into this concern.

Edna Olmeda: Ms. Olmeda is here to express her concern of the new policy implementation. She said she was "caught off guard". She reminds the board of the scene that transpired at the last meeting in which a fellow community member was escorted out. Ms. Olmeda says she is very disappointed at Mrs. Oliveros and even disappointed with the superintendent for implementing this. Ms. Olmeda now addresses Dr. Cruz and says she has learned that he moved to implement this policy. A policy that according to Ms. Olmeda "is not necessary". Lastly, she addressed Ms. Oliveros to remind her she had voted and campaigned for her.

Danielle Martinez: Ms. Martinez questions the board regarding a K-9 "Xanti" that had been retired (transfer of ownership) and reinstated. She claims that the K-9 had been retired to her handler when that person retired as well. Ms. Martinez says she has the documents to prove this and that animal advocates and Texas Rangers will be involved.

Lamcy Rincon: Ms. Rincon begins by speaking on her academic accomplishments and how her parents have instilled that God is first and secondly the importance of their first amendment rights. She states that her father strongly believes in his rights and thus has been arrested nine times in the past 4 years and has prevailed in each case. Ms. Rincon says that her dad received a letter from the superintendent banning him from the district without due process and thus cannot attend this meeting. Lastly, she stated how her dad is her hero and he sets a great example for her and her family.

Valentin Ruiz: Mr. Ruiz addresses his prior request of allowing public comments for Ms. Keila Sanchez went after him, and accused "Jr." (legal counsel) for not allowing that to happen and thus Ms. Sanchez had to "wing it", and also accused the board for having no empathy for Ms. Sanchez. Mr. Ruiz continues to address the board and expresses his opposition to the board hiring another million dollar law firm and says that those million dollars could be used for "a living wage for teachers, paras, custodians, food service and transportation" personnel. Lastly, he addresses Ms. Oliveros and accuses her for being responsible for last month's disturbance and said "an attack on one of us is an attack on all of us".

The visit with TEA included addressing seeking and implementing initiatives to improve teacher retention and recruitment, advocating for increased state funding for public education and resources, and explored policies related to mental health and social & emotional learning among other important topics.

Dr. Cruz also congratulates Kazen Elementary faculty, staff, students and parents for being awarded a 2024 National Blue Ribbon School. Lastly Dr. Cruz, provides an update on the implementation of the "United Cares" program and congratulates the staff recognized for their dedication in creating a positive and supportive environment for students, staff and parents. In addition, he recognizes the Shipping and Receiving department for the long hours and hard work in the distribution of cases and cases of bottled waters provided to our campuses and departments. In closing, Dr. Cruz thanks all administrators, board members and management team on Boss's Day and recognizes their commitment and unwavering dedication to our district and community.
