Discussion of Attendance Boundary Modifications Due to the nature of rezoning for two new campuses, all campuses in the Braswell Zone will be impacted in some way by this proposal presently or in the future. The Fred Hill zoning proposal will positively impact the future growth forecasted for Providence Village and the Cross Oaks campuses. Due to the growth in this area, Sandbrock Ranch Elementary and Union Park Elementary are overflowing with students who are new to our district to Paloma Creek Elementary. This proposal will prevent the interruption of our current students' educational opportunities, minimize travel north and south of Highway 380 and allow for future growth.

Quarterly Growth Report 3rd Quarter 2023 Rocky Gardner, Zonda Demographics presented the 3rd Quarter Growth Report. Currently Denton ISD has 32,905 students for enrollment with a projection of 362 student growth.

Rocky stated DFW area economy has a strong housing growth with unemployment rates below 5%. Once interest rates started to climb, the housing market flattened out because people just couldn't get into homes. Builders start to work off their inventory, then starts began to fall below closings. 3rd Quarter starts increased by 44% and 3rd Quarter Closings increased by 40% in the last 12 months.

Based on current trends, Denton ISD could close more than 3,200 homes by the end of 2023, the most annual closings the district has ever experienced

Denton ISD added nearly 362 students this fall as the housing market continues to have record high closings in the region.

The district has 58 active subdivisions with lots available to build on and 31 future subdivisions with lots in various stages of development. Groundwork is underway on roughly 2,540 lots across the district. The district is forecasted to enroll more than 36,800 students in 2028/29, and almost 41,600 students in 2033/34
