Dear Mr. Mwarey and Hydaburg School Board Members,

As of October 26, 2016, your school board is required to approve sex education within your schools which includes the instructor and curriculum, literature and materials. Furthermore, schools are required to receive parental permission for students to attend sex education classes. http://www.akleg.gov/basis/Bill/Detail/29?Root=HB%20156

Craig Public Health Nursing has provided schools with health education classes in the past which include: puberty, reproductive health, healthy relationships, sexually transmitted infections and birth control options. We would like to continue to offer you these classes. We believe that sex education plays a vital role in providing young people with information they need to protect their health and futures.

We suggest the following courses for your students:

- 5th graders: "Just Around the Corner for Girls" and "Just Around the Corner for Boys" 15 minute video on when to expect the onset of puberty, the reproductive system, importance of good hygiene, maintaining health through good nutrition and exercise.
- Puberty and Reproductive Health course for middle school students. One 45 minute class. PowerPoint presentation focusing on anatomy and physiology of both the male and female reproductive systems, conception, menses (for female students), puberty, selfcare (hygiene, regular exercise, healthy diet), healthy relationships, risk of sexual activity: unintended pregnancy and sexually transmitted diseases.
- Reproductive Health, Pregnancy Prevention and Sexually Transmitted Disease course for high school students. Three 45 minute classes.
  - ➤ Day #1: Take Pre-Test. Brief review of Anatomy and Physiology of the reproductive systems, "Am I Ready? Making Healthy Sexual Decisions" 24 minute video and/or "Me and My 500 Friends. Staying Safe on Social Networks" 20 minute DVD.
  - ➤ Day #2 PowerPoint Presentation on STDs.
  - ➤ Day#3 PowerPoint Presentation on Contraceptive Methods. Review of materials using Class Jeopardy. Take post-test

We would also be very interested in reviewing any culturally appropriate curriculum or resources you might have to use.
