We are pleased to provide the following information & cost for installation of Owner furnished Marquees at subject campuses.

**Work to be included at each campus:**

- 1). Materials, labor, supervision, plant, equipment, permits, & insurance.
- 2). Excavation & haul-off of excess soils
- 3). Furnish labor & materials to form, place reinforcing, anchor bolts & concrete for marquee foundation.
- 4). Pick-up signs from CISD Facilities warehouse & transport to each campus.
- 5). Assemble & erect marquee signs.
- 6). Electrical work to include conduit & 277 volt, single phase wiring from existing electrical panel at main buildings to point of connection at marquee; final electrical connection at marquee.
