# **Meeting Minutes**

December 17, 2013

The Collin County Community College District ("Collin College" or "District") conducted its regular monthly Board of Trustees meeting on December 17, 2013, in the Board Room, Room 139, Collin Higher Education Center, with Chairman Mac Hendricks presiding. Trustees in attendance were Ms. Stacy Anne Arias, Dr. J. Robert Collins, Mr. Andy Hardin, Ms. Jenny McCall, and Mr. Adrian Rodriguez, Mr. Tino Trujillo, Mr. Larry Wainwright, and Ms. Nancy Wurzman. Other attendees included District President Cary A. Israel, Collin College administrators, faculty, students, staff, community members, and vendor representatives.

### **CALL TO ORDER**

Chairman Hendricks called the December 17, 2013, meeting of the Board of Trustees of Collin County Community College District to order at 5:50 p.m. The Board met at the Collin Higher Education Center, 3452 Spur 399, McKinney, Texas 75069.

### ADJOURNMENT TO CLOSED OR EXECUTIVE SESSION

Chairman Hendricks recessed the meeting to closed session at 5:51 p.m. in Room 135, Board Conference Room, as authorized by Article 551.001, Texas Government Code, Sections 551.071 Consultations with Attorney; 551.072 Deliberations about Real Property; and 551.074 Personnel Matters.

Chairman Hendricks reconvened the meeting at 7:00 p.m. in Room 139 and welcomed those in attendance. Chairman Hendricks called on Shirley Harmon, Executive Assistant to the President/Secretary to the Board of Trustees, to certify posting of the notice of the meeting.

On motion of Ms. Arias, seconded by Mr. Hardin, the Board of Trustees of Collin County Community College District unanimously approved the minutes of its November 26, 2013, regular meeting.

#### **PUBLIC COMMENTS**

No public comments were presented.

#### PRESENTATION:

Representatives from the city of Celina and Celina ISD made a presentation to the Board of Trustees regarding rapid growth expected in the Celina region and their desire for Collin College to build on the land the college owns in Celina. Celina Mayor Sean Terry introduced Mayor Pro Tem Carmen Roberts, Councilmen Wayne Nabors and Vincent Ramos, City Manager Mike Foreman, EDC Director Corbett Howard, Andy McAnally of the Celina Chamber, and acknowledged citizens who were present. He thanked the Board of Trustees for the opportunity to talk about the city of Celina. Mayor Terry introduced Celina ISD President Choc Christopher to say a few words. Mr. Christopher introduced Celina ISD board members Pam Peters and Kelly Juergens, Superintendent Donny O'Dell and Assistant Superintendent Rick DeMasters. Mr. Christopher said that Collin College has served the citizens and students of Celina for several years and has provided great opportunities for Celina, not only with dual credit but potentially with a regional academy. He said the students and citizens are thankful for the opportunities the college has afforded. He added that Celina wants to extend that relationship and he and the citizens look forward to Collin College having more of a presence in their city.

Mayor Terry said that the college has bought acreage in Celina, indicating that it might build a campus there. The citizens of Celina believe that day has arrived and that current indicators including housing development show a cycle of aggressive growth has begun. This means more rooftops and families looking for quality employment and educational opportunities. Mr. Terry said the college's presence in Celina will enhance the citizens' quality of life and is the pipeline to greater education and economic opportunities. He said it is their goal to support the concept of a regional academy that is limited only by creativity. The citizens of Celina are excited and grateful for the opportunity to share the vision and contribute to its realization. Mr. Terry said the citizens of Celina would do all in their ability and scope to be an active and supportive partner to the college.

Corbett Howard, Executive Director of Celina Economic Development Corporation, referenced the college's strategic goals for 2013-2016 as it relates to development of a campus in Celina and the target action of using data to project future campus and programming needs. Mr. Howard said the goal of the night's presentation was to assure the Board of Trustees that the corporate commitment of both the city of Celina and the Celina ISD is all about Collin College. In addition, Mr. Howard provided each board member with a packet of materials containing information, category maps, narratives and data on population, housing, and economic growth in Celina, Texas.

# 2013-12-3 Approval of the Comprehensive Annual Financial Report (CAFR) and Related Report for Fiscal Year 2012-2013 from Independent Auditors Grant Thornton LLP

BE IT RESOLVED, at the recommendation of the Budget and Finance Committee and the President, that the Board of Trustees of Collin County Community College District approves the Comprehensive Annual Financial Report (CAFR) and related report for Fiscal Year 2012-2013 from independent auditor Grant Thornton, LLP.

Ben Kohnle, Engagement Partner for Collin College with Grant Thornton LLP, Independent Auditors, discussed Collin College's 2012-2013 Comprehensive Financial Audit Report (CAFR). He said he met earlier in the day with the Board's Budget and Finance Committee, along with President Israel and key financial administrators. Mr. Kohnle said the outcome of the financial audit showed an unqualified or "clean" opinion.

Mr. Kohnle said there was no scope limitation placed on his staff by management. He said there were no unresolved issues and no audit adjustments. There was open and effective communication with the college's management team.

Discussing the student financial aid portion of the audit, Mr. Kohnle said there was a clean opinion and no findings regarding this area. He alluded to past issues in this area and encouraged the Board of Trustees and management to stay diligent in this area.

Trustee Hardin, Chair of the Budget and Finance Committee, thanked Mr. Kohnle and his team for their hard work. He said it was a much better outcome this year and thanked President Israel for taking to heart what the board said last year in light of findings regarding financial aid.

On motion of Mr. Hardin and the Budget and Finance Committee, seconded by Ms. Wurzman, the Board of Trustees of Collin County Community College District unanimously approved the Comprehensive Annual Financial Report (CAFR) and related report for Fiscal Year 2012-2013 from independent auditor Grant Thornton, LLP.

President Israel said he was appreciative to the Board of Trustees for their direction. He said it was important that issues not be hidden and appreciated the support.

BE IT RESOLVED, at the recommendation of the President, that the Board of Trustees of Collin County Community College District approves, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged and confessed, to hereby ALTER, CHANGE and AMEND the Permanent Easement Agreement as follows and it is further agreed and understood that with the exception of the changes set herein,

all of the terms and provision as set out in the Permanent Easement Agreement as originally executed remain unchanged.

President Israel said that Chairman Hendricks, Vice President/CFO Ralph Hall and he had spent time researching this amendment, had done due diligence and recommended the changes as proposed.

On motion of Mr. Rodriguez, seconded by Ms. Arias, the Board of Trustees of Collin County Community College District unanimously approved action, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged and confessed, to hereby ALTER, CHANGE and AMEND the Permanent Easement Agreement as follows and further, agreed and understood that with the exception of the changes set herein, all of the terms and provision as set out in the Permanent Easement Agreement as originally executed remain unchanged.

Notwithstanding anything contained in the Permanent Easement Agreement to the contrary, the parties hereto do hereby agree to amend the Permanent Easement Agreement by substituting, and replacing in their entirety, the plat and metes and bounds description dated September 11, 2013, which is attached here to as Exhibits "A" and "B", in the place and stead of the Exhibits "A" and "B" of the Permanent Easement Agreement filed under Document NO. 2013731001073210 of the Official Public Records of Collin County, Texas.

Ralph Hall, District Vice President of Administrative Services/CFO presented the following information reports:

### Budget Status Report as of 11/30/13

For the month ending November 30, 2013, expenditures exceeded revenue by \$2,850,797; however, year-to-date revenue exceeded expenditures by \$2,463,913.

# Investment Schedule as of 11/30/13

Investments for the month of November totaled \$221,104,857 with TexPool paying 0.04% and TexStar 0.04%. The U.S. Treasury benchmark was .04% on November 1, 2013, and .06% on November 30, 2013. Mr. Hall said he had also invested in Fannie Mae last week for a six-month period at 14 basis points.

# Quarterly Investment Report Ending 11/30/13

Since Mr. Hall presents a monthly investment report, he did not elaborate on the quarterly figures.

### Quarterly Summary of Foundation Payments to the District 11/30/13

Payments to the District from the Foundation totaled \$10,962 for the quarter September 2013 through November 2013; cumulative year-to-date payments also totaled \$10,962.

- at the Third Annual Commendation event hosted by U.S. Congressman Sam Johnson at the Spring Creek Campus on December 14. Dr. Israel said he was honored to participate and appreciated Congressman Johnson for his support and recognition of the college and our veterans. Hearty congratulations and our utmost gratitude go out to John, Shep, and Stephanie.
- 2. Very special thanks go to Vice President/Provost Mary McRae, Chief Gromatzsky and our police officers, physical plant employees, and everyone involved in opening the Spring Creek Campus at 4:30 a.m. to Oncor workers in order to feed them and let them have a respite from the weather. Three hundred fifty (350) workers were in the area from Alabama to help restore the electricity to tens of thousands of people who lost power due to the ice storms.
