Administrative Liaison Meeting Minutes December 16, 2013

1. Announcements/Reminders/Follow-up

- a. Professional Development opportunities were distributed.
- b. Region II Meeting notes—Check isbe.net for CSN FAQ; it was pulled for revisions and, according to Juanita (D303), it is back up again. The PEAC draft for special educators is almost ready; should be Jan/Feb. SELA Drive Around will feature Tim and Judy's topic, special education observations/evaluations. Check that all paras have registered their licenses by December 31.
- c. SLP option on February 28. D303: Strengthening the Core is the only option, specifically for SLPs. Carla will look up the webinar options to see if they could also be offered. Batavia has the space. It's best to have all of the possible options together before notifying staff.
- d. Facilitated IEPs: Regions I and II are interested in co-hosting. We will be confirming the details as soon as Bonnie returns. Suggesting Pheasant Run.
- e. Administrator Breakfasts: Although these sessions are a good and necessary idea, they will be cancelled for the remainder of this year. We will try to schedule a full-day session for the summer.
- f. License renewals information was distributed.

- j. Student transportation and special education. It is a suspension if the student does not have access to education. If removing the child from transportation results in no access, then the days should count. If the parents transport, it is not a suspension. On day 11, if they have special education transportation, they need education access, perhaps another transportation option or homebound, or you will need to meet to "change the placement".
- k. Threat assessment: Send any assessment information to Fran, if you have it.
- 1. ECE: Indicator 12: Start the IEP on the same day that you meet, by the time that the student is three, or when the service starts.

- 4. Annual Needs Assessment: Ready to go. It will be sent to each Administrative Liaison after winter break.
- 5. Behavioral Technical Assistance: Next meeting.
- 6. New requirement: Plans for implementation.
 - a. HB 3070: the warning signs of mental illness and suicidal behavior (instead of just suicidal behavior). To be enacted January 1, 2014.
 - b. Maureen Joy from D303 has information about modular presentations from Infinitec.
 - c. Get a group together in the spring and perhaps into the summer. We will look at possible dates to plan.
- 7. Another new requirement: Sexual predator training all ages, grades (Sarah Erin's law): Next meeting.
- 8. Enrollment update
 - a. New Directions (long-term sub or hire a teacher?) The enrollment indicates that a new teacher should be added, even if the position only lasts until the end of the year.
 - b. CLASS (Primary/Int at Western Ave; MS option at GMSS) D303 may start its own primary program. If so, the numbers (that are already very low) will be even lower. In addition, very few students are currently projected for the intermediate class. D304 has offered one of their middle schools as a site for the middle school class. The numbers do support opening a MS CLASS program. At this time, all districts will be examining their student rosters to see who might be appropriate for CLASS primary and/or intermediate. Paige will also review current New Directions students who may need a "step-down" program, like CLASS. D303 will be making its decision in January. Nothing is firm yet.
 - c. ELS (Blackberry Creek, Prairie Knolls): No real changes for the program, but will need Kindergarten numbers for all programs, including New Pathways.
 - d. High functioning autism at HS: Still no space.

 - b. In addition, she shared an example "Personal Needs Profile (PNP) to record accommodations for students with and without disabilities.
 - c. It was determined that each district would conduct their own training and that more information is necessary from the state.
