DMA (Local)

The Superintendent shall recommend the District's professional development plan for all District employees. The Board shall annually review the professional development clearinghouse published by the state Board for Educator Certification (SBEC) and annually approve the District's professional development plan. The District's professional development plan must:

- Be guided by the SBEC clearinghouse training recommendations;
- 2. Note any differences in the District's plan from the clearinghouse recommendations; and
- 3. Include a schedule of the required professional development for all District employees.
