

*The acting board chair will ask for nominations three times, pausing to allow any board member to nominate. Any board member may nominate any member of the board for the position being filled. Once nominations have been called for three times, the acting chair will close nominations for the office. If only one person has been nominated, the acting chair will then declare this person elected. If more than one person has been nominated a vote must take place. A simple majority is all that is required for election to these offices. Once the new chair has been elected, this person will then preside over the election of all other officers using the same procedures as before. Nominations are called for three times, motion to cease nominations, election.*
