Type of Project/Service (be specific): The Speech/Language Pathologist will provide speech/language tele-therapy services to include but will not be limited to testing, identification, therapy, writing evaluation reports, conducting evaluation report meetings, supervising therapy aide, writing individual education plans (IEP) and conduct IEP meetings as necessary, writing therapy reports, and will maintain appropriate records to meet state and district requirements. The SLP is contracted for 187 days to follow the Browning Public Schools adopted 2026-2027 school year calendar (PI & PIR Days), will be required to work additional days due to emergency cancellations (weather, water, etc.) without additional compensation, also excludes identified BPS holidays and weekends. The speech/language pathologist will provide the district with appropriate proof of current licensure, individual liability insurance, and W-9. A 30-day notice is required for termination of contract by contractor or by Browning Public Schools.
