Mike Lamberty of Aires reviewed the bids and provided comments on the packages submitted by the three lowest bidders. Based on his comments, Holian Asbestos & Encapsulation Corporation is recommended as the asbestos abatement contractor for this Project.

In order to expedite the process and in expectation that the Board of Education will act on the recommendation put forth, a letter has been sent to Mr. Kent Cook at the Illinois Department of Public Health. The letter states that the building is closed and requests that the school be removed from the requirements of Title 77, Chapter I, Subpart p, Part 855 which concerns asbestos abatement for public and private schools. Additionally, a Letter of Intent was issued to Holian to proceed with permitting to assure the timeline of the project.
