Usage fee:

All water customers will be charged \$6.00 per 100 cubic feet of usage in addition to the readiness to serve charge for bills rendered on or after September 2 , 2017.

Quarterly Billing Rates:

Quarterly rates will be three times the readiness to serve charge plus each water customer will be charged \$6.00 per 100 cubic feet of usage.

SEWER RATES

Sewer rates for service on bills rendered on or after January 02, 2026

Where the premises are served by water which is metered, the monthly charge shall be based upon water consumption and shall be computed at a rate of ~~\$2.32~~ \$2.44 per hundred cubic feet. Additionally, there shall be a minimum monthly readiness to serve charge of ~~\$25.95~~ \$27.25 for the first unit and \$5.70 for each additional unit.

Where the premises is not served by water which is metered, the monthly charge shall be at a rate of ~~\$38.00~~ \$40.00 per month.
