



**Date of Board Meeting:** February 17, 2026

**Subject:** Bay City Trades School – Phase 2

**Recommendation:** Approve the competitive sealed proposal submitted by BLS Construction for Phase 2 of the Bay City Skilled Trades facility.

**Background and Rationale:**

Following the Board's approval in September to utilize the competitive sealed proposal method for Phase 2 of the Bay City Skilled Trades facility, the College publicly solicited proposals from qualified contractors. Two responsive proposals were received and evaluated by a scoring committee using the criteria established in the solicitation, including experience with comparable projects, project approach, qualifications of key personnel, safety record, and cost.

Based on this evaluation, BLS Construction was identified as the highest-ranked and best-value proposer. Administration is therefore recommending award of a contract to **BLS Construction** for the renovation and build-out of Phase 2 in accordance with the plans and specifications prepared by Able Design Group.


