II. APPROVAL OF MINUTES

A. February 22, 2023 - Regular

Motion: Motion made by Samantha Mannion to approve the minutes of February 22, 2023, as presented. Approved by consensus.

III. ACTION ITEMS

- **A.** Policy 4118.51 Social Media Paul Gouveia, Director of Technology, reviewed his proposed changes to Policy 4118.51 Social Media. He recommended that the policy remove ambiguity, specifically to state that staff may not "communicate with students on social media," not just "friending" students. He also suggested omitting the names of specific social media sites, to cover all such forms of communication. Samantha and Kathy recommended fast tracking the full board approval of the policy due to the urgent need to protect staff and students.
- **B. Policy 3517.1 Identification Badges** Dr. Craw reviewed the proposed changes to the policy as discussed at the previous meeting. The changes state that all middle school and high school students are required to display their badges in a prominent location when boarding the bus. High school students must wear their IDs while in the school building, and middle school students do not need to wear the badge throughout the day.
