A. Policies - Final Reading #705 Investments and Cash Mangement, Gary Kawlewski The maximum percent of portfolio to be invested for certificates of deposit is increased from 76% to 95%.

#### 6. REPORTS

A. Physical Education RESEARCH, Pam Miller

Physical Education Teachers: Marci Wills, Jen Nichols, Jason Karn shared a video of physical education activities around the district. Teachers are examining the program strengths and limitations to formulate an improvement action plan. Obesity is a national problem. Associations are found between physical fitness and academic performance, school attendance and school incidents. Amount of class time varies at each building. Will want to be creative and look at possible schedule changes other than scheduling determined by prep time.

B. Summer Programs, Kim Carlson

This is the fourth year of Summer Block program. Kindergarteners will stay in one classroom for the day which is better for them than moving from class to class. Use bus supervisors. Targeted services program referral has been revised for reading and math. Community Education received a \$10,000 grant for Open Streets which will take place in July through Allina BCBS.

C. Principal Evaluation Revisions, Pam Miller

The review of the principal evaluation process is due to recent legislative changes. A district subcommittee was formed. Job descriptions will also be updated through this process. Seven competency areas are identified under leadership – strategic, instructional, managerial, cultural, communications, school community and ethical and professional.

D. Policies - First Reading #722 - School Attendance Boundaries, Pam Miller Policy provides two guidelines regarding in-district transfer requests. This revision may allow the approval for a request for other reasons, i.e., class size.
