BACKGROUND INFORMATION:

The District has ten (12) school facilities and a District office that is currently equipped with Openeye security cameras, Aiphone devices, and Aurora keyscan software are used to manage access control. The district is seeking proposals to maintain, clean, and troubleshoot this equipment. Gregory-Portland ISD has approximately 86 keyscan panels with 319 doors and their peripheral devices, 87 Wi-Fi gateways for the Wi-Fi locks, 581 Eplex locks, and 29 Airphone devices. In addition, the District has 31 Open-eye NVRs and 901 Open-eye cameras. The Request for Proposals were received on July 15 and the committee will meet prior to Monday July 19th to review, evaluate, score and decide on a proposed recommendation based on the following criteria:

Price (100 points) Prior Experience with GPISD (40 Points) Ability to Handle GPISD ISP Needs (20 points) Reputation of Vendors Services (20 points) SLA and Technical Merit (20 points)

RECOMMENDATION:

The Committee will complete the assessment of the Sealed Proposals and score on the criteria mentioned in the RFP. The committee will have a recommendation based on the top scoring vendor.

FINANCIAL IMPACT:

The current contract with Network Cabling Services is set to total to \$124,476.36, invoiced at \$10,373.03 monthly. This does not include the new Early Childhood Center (which was on warranty this year).
