



## PUBLIC CONTRACTS – BOARD AUTHORIZATION OF SUPERINTENDENT TO OBLIGATE THE DISTRICT

### POLICY ISSUE/SITUATION

School Board action is required to authorize the Superintendent or a designee to obligate the District for the attached public contract items.

### **BACKGROUND INFORMATION**

On May 15, 2017, the Board adopted current policy language regarding Authority to Obligate the District (Board Policy DJ), which updates the School District's Public Contracting Rules in accordance with State Recommended Model Rules. Appropriate bidding procedures and Public Contracting Rules have been complied with before recommending the attached contract for Board approval. The following authorization of contract, subject to available budget appropriations, is a routine Board action that appears under the consent grouping of the Board agenda.

#### RECOMMENDATION

BE IT RESOLVED that the School Board authorize the Superintendent or a designee to obligate the District for the public contract items listed in Attachment A.

**PROJECT NAME:** District-Wide Security Upgrades

**PROJECT TIMELINE:** 9/2014 - 7/2022

**PROJECT BUDGET:** \$10,600,000

**PROJECT SCOPE:** Complete security retrofits in existing buildings as determined by a

site-by-site analysis of needs compared to the security standards.

**CONTRACT NAME:** Security Upgrades Group 3

**RECOMMENDED BY:** Sheri Stanley

**SOLICITATION METHOD:** Design/Build (Solicitation #17-0040)

**CONTRACT TIMELINE:** 2/2018 - 9/2019

**CONTRACT AMOUNT:** Not-to-Exceed \$440,000

**CONTRACT SCOPE:** "Perimeter Hardening" of the final 18 schools not previously completed. In addition, owner directed additions will be completed on the previously completed schools.

**RECOMMENDATION:** Authorization to Award Contract to Kirby Nagelhout Construction Company for Preconstruction and Design Services only. Request for authorization to award construction work will follow via the Design / Build Amendment.

**FUNDING SOURCE:** 2014 Bond Program: Modernization; Regulatory Compliance; Security Upgrades.

**SOLICITATION METHOD:** Invitation to Bid #17-0043

**CONTRACT TIMELINE:** 3/2018 - 9/2018

**CONTRACT AMOUNT:** \$1,983,200

**CONTRACT SCOPE:** Re-roof the balance of the school not completed in Phase 1 (2017), approximately 95,984 square feet of roof, add fall protection anchors (14) and access ladders (4) between levels.

**RECOMMENDATION:** Authorization to Award Contract to: Umpqua Roofing Company

**FUNDING SOURCE:** 2014 Bond Program: Modernization: Renovation Projects; Physical Facility Improvements.

**CONTRACT AMOUNT:** \$18,603.00\*

**CONTRACT SCOPE:** Provide construction management and general contractor services to facilitate and install the replacement HVAC systems and electrical system upgrade at Ridgewood Elementary School.

**RECOMMENDATION:** Authorization to Award Contract to Inline Construction

**FUNDING SOURCE:** 2014 Bond; Modernization, Renovation Projects; Physical Facility Improvements; Ridgewood HVAC and Electrical Upgrade

\*This Contract is for Construction Manager / General Contractor (CM/GC) Services. Although the contract is below the threshold for Board approval, it is anticipated to substantially exceed that threshold once the Guaranteed Maximum Price (GMP) amendment is executed following the design phase. The findings for this Alternative Procurement were approved by the Board on December 11, 2017.
