

AMENDMENT TO STUDENT TRANSPORTATION SERVICES AGREEMENT

This amendment to Student Transportations Services Agreement ("Amendment"), effective as of April 1st, 2021 ("Amendment Effective Date") is executed by and between Mid Columbia Bus Company, Inc., an Oregon corporation located at 73458 Bus Barn Lane, Pendleton, OR 97801 ("MIDCO" or "Contractor") and Morrow County School District #R-1, an Oregon school district located at 235 Stansbury St, Heppner, OR 97836 ("District"). This amendment modifies and supplements certain terms and conditions of that certain Student Transportation Services Agreement executed by and between Midco and District dated July 1st, 2020, as previously amended (the "Agreement").

RECITALS:

- A. The Agreement sets for the terms and conditions under which Midco provides certain transportation services to District; and
- B. The parties desire to modify and supplement the Agreement to extend the term as set forth herein and to update Rate Adjustment criteria for Services.

NOW THEREFORE, in consideration of the mutual covenants and conditions contained in this Amendment, and in the Agreement, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree to modify and supplement the Agreement as follows:

AMENDMENTS:

- 1. <u>Bonus Program</u>. Contractor and District agree that changes are necessary to retain and attract drivers for transportation. In the spirit of making transportation more attractive, and to facilitate full staffing for district needs, Midco has created a bonus program campaign to give new and existing employees a bonus to work for our company and transport your students. A copy of the current campaign is attached in Addendum B. Midco will cover the first \$1,000 of bonuses paid out to new hires, and only bill the district actual dollars paid to a driver.
- 2. <u>Pay Increase</u>. Contractor will be moving starting wages from \$15.50/hr to \$17.00/hr effective at the start of the new school year.
- 3. New Equipment. Contractor will bring on new Type 20 bus to match two other new buses already ordered, to go into service Fall 2021.



- 4. <u>Rate Increase</u>. Contractor and District agree above changes will necessitate a 7.5% rate increase, effective July 2021. The new rate effective until the end of this school year is attached as Addendum A.
- 5. <u>Scope of Amendment</u>. This Amendment will affect only those amendments in the Agreement specifically provided for in this Amendment. Otherwise, the Agreement will remain in full force and effect with no other amendments or modifications except as otherwise provided in other proper amendments to the Agreement.

IN WITNESS, WHEREOF, the parties, by their duly authorized representatives, have executed this Amendment as of the Amendment Effective Date.
