Greetings. 



Determination of NAFIS Dues for the 2020-2021 Membership Year

Section 7003 dues are based on FY 2019 Impact Aid payment Section 7002 dues are based on FY 2019 Impact Aid payment

1. Membership dues are based upon a calculation that multiplies 0.0014 by the Impact Aid payment (Basic Support; Disability; Federal Property) that a school district received for the most recent fiscal year for which final payments have been made or \$350, whichever is greater.

Example: Total Impact Aid payment is \$1,000,000 x 0.0014 = \$1,400 dues payment

 For any amount a school district receives exceeding \$7 million, the dues for receipts above \$7 million will be calculated at one-hundredth of one percent (0.0001 of 1%).

Example: Total Impact Aid payment received is \$10,000,000Step 1 - $$7,000,000 \times 0.0014 = $9,800$ Step 2 - $$3,000,000 \times 0.0001 = 300 Total Amount of dues \$10,100

 Districts in equalized states will have only those Impact Aid funds exempt from State equalization counted toward their membership calculation. Applies only to New Mexico, Alaska and Kansas.
