WORK SESSION: The Board participated in the USBA Annual Conference opening session.

REGULAR SESSION: President Harding called the regular session to order at 7:40 p.m. Mr. Morrill offered prayer. Mr. Thacker led the Pledge of Allegiance to the Flag of the United States of America.

- Board Reorganization President Harding opened nominations for president. Mr. Bench nominated Mr. Harding for President, Mr. Smith seconded, Mr. Morrill moved nominations cease. President Harding opened nominations for vice-president and Mr. Smith nominated Mr. Thacker; Mr. Bench moved nominations cease. Mr. Morrill nominated Mr. Thacker as UBTech representative, Mr. Bench moved nominations cease.

- 1. Enrollment Projection Mr. Miles reviewed declines in birth rates that will translate into declining enrollment over time. Add to that the loss of students to online schools and budgeting will be a challenge.
- 2. Superintendent Brotherson reported on efforts to increase the number of student activities, but that it also could increase the frequency of contact and exposure to the virus. Efforts are being made to minimize exposure as much as possible.
