Prior to the 2010-11 school year, custodial supplies were annually awarded to a single company as opposed to item specific. Commencing with the 2010-11 school year, and continuing forward for the 2011-12, the 2012-13, and, again, now the 2013-14 school year, the Director of Buildings & Grounds, in concert with the Night Custodial Supervisor, has prepared a bid specification that is item specific. In 2009-10, the District spent \$125,000 for custodial supplies, and this amount has been reduced annually-for the 2010-11 school to \$97,913.64; for 2011-12 to \$96,180; and then for last year (2012-13) to \$89,196.76. The reductions in costs were primarily attributable to making the bid item specific but also to using up supplies that had been accumulating and still viable.

With the increased emphasis on "green" products, exhausting ample supplies previously inventoried, increasing enrollments, and the need for introducing not only some new but some higher quality supplies, the bid this year has increased to a recommendation of \$129,527.45, which is a significant increase over prior years. Some of the principal increases in quantity needs are due to use of augmented amounts of paper towels, toilet tissue, waste bag liners, green wipes, hand sanitizers, hand soap, and floor finisher and associated supplies (due to floors being stripped every five years). Norm and I have reviewed every single line item contained in the bid summary to insure the need and quantity are necessary and we affirm that these are accurate.

In anticipation of the 2013-14 school year, a similar bid document was prepared and the appropriate legal notice, which is attached, announcing a bid opening on March 27, 2013, was published in the February 28, 2013 issue of the <u>Oak Leaves</u>. Further, a mandatory pre-bid meeting was held on March 16, 2013, at which time 17 prospective vendors attended (also attached). The list of vendors invited to bid on this project is attached as well. On March 27, 2013, nine bids were received and the itemized bid summary is attached.

Therefore, it is the recommendation of both the Director of Buildings & Grounds and me to award contracts to the following firms in the respective amounts identified, totaling \$129,527.45.
