#### Cooperative Team Agreement between Pana High School and Faith Bible Christian Academy of Rosamond

#### Introduction

This agreement is made by and between the Board of Education of (HOST SCHOOL- Pana High School) and (SUB SCHOOL- Faith Bible Christian Academy).

The purpose of this agreement is to expand equal athletic opportunities in the area of (ACTIVITY- Baseball, Softball, Boys Track, and Girls Track) for (Pana High School and Faith Bible Christian Academy).

This agreement will be for the (YEARS 2018-19 & 2019-20) school years, upon approval of the IHSA. This program will be renewable by mutual agreement between the Boards of Education of the two school districts and the Illinois High School Association.

Transportation will be provided by Pana CUSD # 8.

Squad and Mascot - The squad shall be known as the (Pana High School Panthers) and shall operate with (Navy & Orange) uniform colors. The mascot will be the (Panthers).

Equipment/Games/Officials will be funded by Pana CUSD # 8. FBCA Students will pay a \$ 50.00 fee per sport to compete on IHSA sanctioned teams at Pana CUSD # 8.

Supervision - The administration at each district will be responsible for supervision for home games. All discipline problems will be the responsibility of the home district.

Eligibility - The administration (or designee) at each building will be responsible for checking eligibility of participants. The schools will follow the IESA guidelines.

Insurance/Physical - All participants will be required to have proof of insurance and a current physical on file with their home district. It is the responsibility of the home district administrators or (designee) to make sure these items are on file before participant starts practicing.

Parents - (Pana High School or other privately funded programs) operates a concession stand and has an approved fundraiser by the district for games exclusive of the IHSA state series. Parents of student athletes will be asked to work in the concession stand and the players may be asked to participate in the fundraiser. The proceeds directly benefit the (Baseball, Softball, Boys Track, Girls Track or PCUSD # 8) programs.

All team trophies acquired by the cooperative team will be the property of (HOST SCHOOL - PHS) and a duplicate trophy may be purchased for the (SUB SCHOOL-FBCA).
