PAYMENT OF GRANT: Upon receipt of a signed copy of this agreement a grant check will be prepared and mailed to you.


REPORTING: The Foundation requires completion of a Grantee Evaluation Report upon final expenditure of the funds or by **November 7, 2025** whichever comes first. A copy of your informational brochure or program promotion with the acknowledgement of funding source must be included with the grant evaluation report. The Foundation may periodically monitor implementation of the program through site visits or request interim information.
