

**Troup ISD
Board of Trustees
Regular Meeting
June 9, 2025**

The Troup Independent School District Board of Trustees met in Regular Session, Monday, June 9, 2025, at 6:00 p.m. in the boardroom of the Administration Building, 201 N. Carolina Street, Troup, TX. The meeting was called to order at 6:17 p.m. and presided over by President Shane Jasper.

Members Present: President Shane Jasper; Vice President Todd Kelly; Secretary Lisa Lewis; Members Homer Dickey, Ty Lindsey, and Jake Howard. Vic Bansal was not in attendance.

Under Agenda Item #5: Administrative Reports

A. Support Services- Preston Lindsey

The flooring job at the High School has been completed. Roofers are back to complete the roofing repairs at the High School and are trying to work ahead of the expected rain. The Elementary had a water leak and all efforts are being made to dry the flooring. There was minimal damage to one wall. The DAEP room is being renovated for an office/training area. The student cubicles were removed and will be used at the Middle School. Several air conditioner issues were identified and repairs have been made. Showers at the field house are being repaired and should be completed by end of July. Two buses are having brackets replaced to remove the vibrations from the front mirrors.

Mr. Smith also presented the Notice of Intent to Apply for 2025-2026 State and Federal grants, including the Idea B Special Ed Consolidated Grant, Carl Perkins, and several grants to assist with breakfast and lunch programs.

Under Agenda Item #7: Superintendent's Discussion Items

Superintendent Jones informed the Board of staff training at the campuses over the summer, including, AI, student mental health awareness, and Bluebonnet curriculum implementation training. Board training dates for the Region 7 Summit were discussed. The Legislative session ended last week with 1,482 bills that will affect public education. Policy consultants will be preparing the policy changes and informing the district of legal changes and recommendations for changes to local policies, as well as updating handbooks for staff and students that will reflect the changes. The Facilities Planning Committee will be meeting again at the end of July or early

August. A long term facility plan has been completed. As meetings with architects give a better understanding of pricing and possible options to save costs, more information will be forthcoming to begin to make decisions on any implementation of the projected improvements.

Under Agenda Item #8:

Lisa Lewis made a motion to accept the following consent agenda items as presented: minutes of May 12, 2025, regular meeting; revenue; expenditures; Region VII Education Service Center 2025-2026 Regional Purchasing Cooperative Interlocal Agreement and Resolution; approval to remove Lisa White and add Blake Rowe, as an authorized representative and signer for Austin Bank accounts; and the 2025-2026 Compensation Plan. Todd Kelly seconded the motion.
