



# Cascadia Wildlands v. Kitzhaber










- Plaintiffs sued the state alleging proposed timber sales violates the ESA.
- Plaintiffs also alleged that State forest management plans result in take.
- The State settled the case and paid their attorney fees


















# Take Standard

- Any harvest activities within lands classified as "occupied" amount to "take" in violation of the ESA.
- No peer-reviewed science to back their assertions.
- A vacuum exists because USFW didn't write standards for protecting or recovering Murrelets

Now let's see the impact.



# Short rotation is no guarantee PSG PROTOCOL:

- The **presence of platforms** is best predictor of Murrelet **presence** in an area.
- Any forested area with a **residual tree** should be considered potential Murrelet habitat.



# ODF is working on a new ProtectionProtocol

Funding: ODF Budget - \$450,000

Until then the State must use the existing PSG Protocol

Will the PSG Protocol have an eventual impact on our NW Forests?

### Yes


It's just a matter of time before our forests grow the same nesting characteristics as the Elliott.



# Why should we be so concerned?

- Our mills are in jeopardy of closure.
- Family wage jobs may be lost.
- Our county and school budgets may see significant cuts.

Two sales have already been halted in Tillamook County.



Now these same environmental groups have requested ODFW upgrade the Murrelet from Threatened to Endangered under Oregon's ESA

ODFW agreed to conduct a study to determined if an Upgrade is warranted.

ODF turned down a request to amend the Forest Practices Act to increase Murrelet protections on private forest lands.

I can't help but question their motives.

- The Oregon Department of Forestry's financial crisis:
  - What happened to cause it and what they are doing about it.
- The Linn County Class Action Lawsuit:
  - o \$1.4 Billion
  - o Recent rulings have been very good
  - Judge Murphy has determined schools and special districts have equal status as the counties
    - > What that means for you

Are current forest management policies harmful to fish and the environment?

The Trask Paired Watershed Study:

An Unprecedented 6,000 acre, 11 year study of stream buffers and the effects of contemporary Forest practices.

# Smolt and Fry Counts leaving our forest systems

A few years ago, ODF and the ODFW placed non-lethal fish traps on a few tributaries to research how many young fish were being produced and out-migrating to the ocean.

One trap was on a tributary to the Little North Fork of the Wilson River. In just one year, **1.4 million Chinook**, **154,000 Coho**, and **11,000 steelhead fry** out-migrated from the Little North Fork.

This 12-mile long Wilson River tributary is only one of many tributaries within the five rivers within the Tillamook State Forest.
