I. SUPERINTENDENT'S REPORT

A. Staffing Update: Supt. Glaes reviewed the listing of open positions and staffing changes to date.

- B. Review of MME Scores for Class of 2015: High School Principal Keevin O'Neill reviewed the MME scores, provided a brief analysis of the results, and shared his thoughts regarding the issue along with plans for 2014-15.
- C. School Board Election November 4, 2014: Supt. Glaes stated that Wil Emmert and David Schriemer plan to run for re-election at the November 4 election. Tom Danielson has decided not to run. One person has expressed interest.

II. REPORTS AND PUBLIC INQUIRY

- A. Financial Report Steve Goss
 - 1. Budget Progress Report for Month Ending June 30, 2014:
 Asst. Supt. Goss reviewed the budget progress report for June, 2014 showing total revenues of \$19,965,112; total expenditures of \$22,435,219; and deficiency of revenues over expenditures of -\$2,470,107.
 - 2. HS Fire Alarm Replacement: Mr. Goss stated that the District received 4 bids for the replacement of the Vicksburg High School fire alarm system. The lowest two bidders, Hoekstra Electric and Hi-Tech Electric, were interviewed by a team consisting of staff from VCS, Frederick Construction, and Tower Pinkster. Based on the results of the interview, the administration recommends awarding the contract to the low bidder, Hoekstra Electric, with a base bid of \$149,000.
 - 3. MS Traffic Flow Improvements: Mr. Goss reported that bids were received today. There are six components to the bid and there were 13 bidders. Mr. Goss requested approval to enter in contract with the low bidders of Hoekstra Electric, Bailey Excavating, Farley and Associates, Farm N Garden, and JD Vliestra Co. The project completion time will be close to school start up.
- B. Instructional Report Charles Glaes
 - 1. Textbook Proposals John O'Toole
 - a. VHS and VMS World Language -Spanish

Textbooks: This request increases Advanced Placement courses at the High School in World Language.

- K-8 Math Instructional Resources: This request will bring the resources into alignment with the Common Core State Standards of Mathematics.
- 2. Preschool Pilot: Supt Glaes stated, that pending approval from MDE, the District intends to operate its 2014-15 GSRP Program, which has been renamed Bulldog Beginnings, at each elementary school as a full day, five day per week program. The program will be monitored carefully in order to determine the difference in student achievement anticipated with a longer program, and will report the evaluation results next year. Because this is a substantial change in how the program has been operated and because the State's rules regarding combining of GSRP slots to program full day programs could change, the Board was asked to approve the program on a pilot basis under the assumption that theDistrict will be awarded sufficient slots by MDE and KRESA.
