Board Member _____ introduced the following resolution and moved its adoption:

**RESOLUTION APPROVING THE PURCHASE AGREEMENT BETWEEN
INDEPENDENT SCHOOL DISTRICT NO. 256 AND BRIAN AND GRETA SCHREIBER
FOR THE SALE OF THE PROPERTY LOCATED AT: 30000 SKI ROAD, FLORENCE
TOWNSHIP**

WHEREAS, Independent School District No. 256 (the "District") and Brian Schreiber and Greta Schreiber, married to each other (collectively, the "Buyers"), desire to enter into a purchase agreement (the "Purchase Agreement") pursuant to which the District will convey certain property consisting of approximately 1 acre of vacant land owned by the District and located at 30000 Ski Road, in Florence Township (the "Property") to the Buyers; and

WHEREAS, the Property is legally described as: One acre of the East ½ of the Southeast ¼ of Section 7, Township 112, Range 13, Goodhue County, Minnesota (PID No. 32.007.0800); and

WHEREAS, pursuant to the Purchase Agreement, the District will convey the Property to the Buyers for a purchase price of \$3,250.00; and

WHEREAS, the District finds that the conveyance of the Property is desirable and in the best interest of the District.

BE IT RESOLVED by the School Board of Independent School District No. 256 as follows:

1. The Purchase Agreement is hereby approved in substantially the form presented to the District, subject to modifications that do not alter the substance of the transaction and that are approved by the Board Chair and Board Clerk of the District, provided that execution

of the Purchase Agreement by those officials shall be conclusive evidence of their approval.

2. District staff and officials are authorized to take all actions necessary to perform the District's obligations under the Purchase Agreement as a whole, including without limitation execution of any documents to which the District is a party referenced in or attached to the Purchase Agreement. The Board Chair and the Board Clerk are authorized to sign the quit claim deed on behalf of the District. Frank Norton, Superintendent, is authorized to sign all other closing documents on behalf of the District for the District's sale of the Property to the Buyers in order to complete and effectuate the sale.
