

Resolution for Notice of Public Meeting to Discuss Budget and Proposed Tax Rate

WHEREAS, the Board of Trustees of the Coppell Independent School District (the "District") has reviewed the proposed Budget prepared by the District's administration for the 2011-2012 school year pursuant to Texas Education Code § 44.002;

WHEREAS, in accordance with Texas Education Code § 44.004 and § 44.0041, the District must provide for a published notice related to the proposed budget and concurrently post a summary of the proposed budget on the District's website, and then conduct a public meeting to discuss the adoption of its budget;

WHEREAS, the Board of Trustees of the Coppell Independent School District has determined that the following proposed tax rates shall be included in the Notice of Public Meeting to Discuss Budget and Proposed Tax Rate for the Coppell Independent School District's maintenance and operations and debt service;

Maintenance Tax \$1.17/\$100 (proposed rate for maintenance and operations)

School Debt Service Tax <u>\$0.2542</u>/\$100 (proposed rate to pay bonded indebtedness)

WHEREAS, in accordance with Texas Education Code § 44.004, the District will timely publish the statutory Notice of Public Meeting to Discuss Budget and Proposed Tax Rate and thereafter conduct a public meeting on August 29, 2011 to discuss the District's budget and tax rate that will be proposed for adoption, and during which meeting public participation in the discussion is invited;

NOW, THEREFORE BE IT RESOLVED that the Board of Trustees of the Coppell Independent School District, and its President, provides for and authorizes the Superintendent of Schools to take whatever steps are necessary for the publication of the statutory "Notice of Public Meeting to Discuss Budget and Proposed Tax Rate," in the form and manner required by law, with said Notice to be published on **August 10th and 12th**; and

BE IT FURTHER RESOLVED that concurrently with the publication of the "Notice of Public Meeting to Discuss Budget and Proposed Tax Rate" that the Coppell Independent School District shall post a summary of the proposed budget on the District's internet website, in the form and manner required by law; and

BE IT FURTHER RESOLVED that the public meeting to discuss the District's budget and proposed tax rate shall be published to be held on <u>August 29th at 6:00</u> <u>PM, at the Vonita White Administration Building, Boardroom, 200 S. Denton Tap, Coppell, Texas, 75019.</u>
