4. DISCUSSION/CONSIDERATION

1. 2021-2022 Fiscal Year Budget

Assistant Superintendent for Business Services Todd Latham shared with the committee the final proposed 2021-22 budget. The changes from the tentative budget were in Personal Property Replacement Tax, debt service transfer, food service, State and federal grants, transportation, and capital projects. The tentative budget showed revenue of \$111,676,984 and the proposed now shows revenue at \$113,592,038. The tentative budget showed expenditures of \$112,296,619 and the proposed now shows expenditures at \$113,173,822. This gives us a balanced budget for the 2021-22 fiscal year, with a surplus of \$418,216. If approved, the next step is to file the budget with the Kane County Clerk's office, upload the approved budget to the Illinois State Board of Education, adopt the 2021-22 budget in

Skyward, update the September Treasurer's Report, and begin preparing assumptions, forecasting for FY23 and Meritorious Budget. We are recommending that the committee approve to move this forward to the full Board.
