

**RESOLUTION AUTHORIZING TRANSFER FROM  
TORT IMMUNITY FUND TO PAY ASSESSMENT**

**WHEREAS**, the Board of Education of Pana Community Unit School District No. 8 (“the District”) is a participating member of Egyptian Area Schools Employee Benefit Trust (“Egyptian Trust” or “the Trust”); and

**WHEREAS**, the District and other participating members of Egyptian Trust have received notice of a special assessment because the Trust had more liability in outstanding claims than revenue to pay those claims; and

**WHEREAS**, the Trust has assessed the District the total amount of Two Hundred Thirty-seven Thousand Seventy-seven and 00/100 Dollars (\$237,077.00), which is payable no later than \_\_\_\_\_, 2025 (“the Assessment”); and

**WHEREAS**, Section 9-107(b) of the Local Governmental and Governmental Employees Tort Immunity Act, 745 ILCS 10/9-107 (“the Tort Immunity Act”) authorizes a school district which is a member of a joint-self-health-insurance cooperative to adopt a resolution authorizing a one-time transfer from the Tort Immunity Fund to the fund or funds from which payments to the joint-self-health-insurance cooperative can be or have been made in the event said cooperative has notified the district that it had more liability in outstanding claims than revenue to pay those claims; and

**WHEREAS**, the Board of Education finds and determines that it is in the best interests of the District to transfer from its Tort Immunity Fund to its Education Fund the amount of Two Hundred Thirty-seven Thousand Seventy-seven and 00/100 Dollars (\$237,077.00) in order to pay the Assessment to Egyptian Trust.

**NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED** by the Board of Education of Pana Community Unit School District No. 8 as follows:

**1. Incorporation of Recitals.** The Board hereby finds that all of the recitals contained in the preambles to this resolution are full, true and correct and does incorporate them into this resolution by this reference.

**2. Transfer from Tort Immunity Fund.** The Superintendent and Treasurer are hereby authorized and directed to take all necessary steps to transfer the sum of Two Hundred Thirty-seven Thousand Seventy-seven and 00/100 Dollars (\$237,077.00) from the District's Tort Immunity Fund to the Education Fund for the purpose of paying the Assessment to the Egyptian Trust as described above.

**3. Effective Date.** That this Resolution shall be in full force and effect forthwith upon its adoption.
