Tab Two- Clarifications & Assumptions (C&A)

General Qualifications

- This proposal is based upon the drawings Issued for Bid dated June 7, 2022 for the South San Antonio ISD West Campus High School – Cafeteria Package by PBK Architects and their consultants.
- 2. We have included a Construction Manager Contingency of \$ 10,000 dollars for CM's exclusive use.
- 3. Proposal is based upon using the TIPS process. We have included a TIPS Fee of 2%.
- 4. We have included builder's risk insurance, general liability insurance, subcontractor default insurance and payment and performance bonds.
- 5. If it is determined that items we have excluded are required to be included, such items will be addressed by contract change. Changes requested may require an increase to the contract amount.
- 6. We have not included any costs for unforeseen conditions.
- 7. Our proposed work is limited to the following scope items:
 - 1. Demolition of existing walls in rooms 101, 109 and 110.
 - 2. Constructing and finishing new drywall partition type S6 between Existing District Storage and the proposed Cafeteria A420
 - 3. We will include electrical power located within the new drywall partition. Cost for this work will be from the allowance included in our proposal.

Package Specific Assumptions & Clarifications

The following definition represents the basis of our proposal and serves as the Cafeteria Package Estimate for the project. The estimated costs were developed based upon the project documents listed in the appendices and schedule data described elsewhere in this report, and the assumptions, clarifications and design criteria presented under this section.

Division 1:

1. We have included allowances for all MEPS work that will need to be completed.

Division 2:

1. We have included demolition of the interior walls located in rooms 101, 109 and 110.

Division 7:

1. We have included firestopping at new drywall partitions.

Division 9:

1. We have included to tape, float and paint of the new drywall partitions.

Miscellaneous:

1. We have included general labor for clean-up, protection of existing conditions, final clean and safety.

Contract Allowances

To provide this Cafeteria Package Estimate proposal, a number of cost allowances had to be established. These allowances are intended to provide for all direct construction costs associated with each of these items.

1.	CM Contingency - \$10,000
2.	MEPS Allowance – Make Safe at Demo Areas\$10,000
3.	MEPS Allowance – \$15,000

Exclusions

- 1. All scope of work not included in the demolition of the Existing District Storage and the enclosure of the Cafeteria.
- 2. All MEP scope of work shown in the drawings
- 3. All Technology shown in the drawings
- 4. Temporary power and water consumption cost for new construction. We have included the use of the services provided by the Owner.
- 5. Design contingency
- 6. Furnishings, Fixtures or Equipment.
- 7. Sales Tax.
