Board Chair Johnstun called the meeting to order at 6:10 p.m. and led the audience in the Pledge of Allegiance.

AGENDA APPROVAL

Member Fischer-Maki made a motion to amend the agenda to add: Action item #9E-Resolution to transfer appropriations from contingency to support the ELL program; Action item #9F-Memorandum of Agreement-Three Rivers Education Association-HB 4030 funds; and Action item #9G-Hidden Valley HS scoreboard advertising agreement with Evergreen Federal Bank. Member Wright seconded the motion; the motion passed unanimously (3-0 – Members Halsted and Searle absent).

REPORTS - NO ACTION

Oregon English Language State Report for 2020-2021

 Director Durrant provided information on the data in the report and provided a link to the ODE report in the board packet.

Board Policies - First Reading;

- o IGAEA HIV, AIDS, HBV, and HCV, Health Education DELETE
- o IGAEB Drug, Alcohol, Tobacco, and other Inhalants Prevention, Health Education
- o IGAI Human Sexuality, AIDS/HIV, Sexually Transmitted Diseases, Health Education
- Director Durrant brought forward two health education policies that have been revised and one for deletion because it has been rolled in to two other policies. Most of the updates and changes to the policies are based on recommendations from the OSBA and dictated by state and federal law.

2021-2022 Physical Restraint and Seclusion Annual Report

 Director Allen-Hart shared that this report is an annual requirement from ODE and explained that physical restraint and seclusion is very rarely needed and only used if there is a possibility of imminent bodily harm. The decrease is largely due to the increase in staff training.

• Fort Vannoy Drain Field Emergency Contract

Superintendent Valenzuela explained that the contract was due to issues uncovered which required emergency work in the amount of \$107,460.

ACTION ITEMS

Kalmiopsis Charter School Proposal

- Superintendent Valenzuela explained that this was a resubmission of their application and recommended the proposal for approval.
- Member Fischer-Maki made a motion to approve Kalmiopsis Community Arts High School charter proposal. Member Wright seconded the motion. There was some discussion and they also shared they are looking forward to the next steps. Board Chair Johnstun called for a vote and the motion passed unanimously.

Modern Building Supply Contract

- Superintendent Valenzuela requested the Board approve the contract with Modern Building Systems in the amount of \$1,661,790 to purchase a 4,760 square foot building for the Fruitdale classroom addition.
- Member Wright made a motion to approve the contract with Modern Building Systems.
 Member Fischer-Maki seconded the motion; the motion passed unanimously.

Memorandum of Agreement – Oregon School Employee Association-HB 4030 Funds

Deputy Superintendent Alderson explained the funds from this House Bill will be used to

- prioritize salary and compensation for our classified employees as well as recruitment and retainment.
- Member Fischer-Maki made a motion to approve the OSEA Memorandum of Agreement for our classified employees. Member Wright seconded the motion; the motion passed unanimously.

Planned Course Statements

- Director Alderson brought forward the following planned course statements for approval:
 - Kinesoilogy
 - Emergency Care
 - Medical Terminology
 - Health Careers Internship (Work Experience)
 - Strength and Conditioning (Middle School)
- Member Fischer-Maki made a motion to approve the planned course statements. Member Wright seconded the motion. Board members shared their excitement over the new learning opportunities for our students. Board Chair Johnstun called for a vote and the motion passed unanimously.

• Resolution (#01) to Transfer Contingency (ELL)

- Director Durrant shared that due to the increase in EL students there is a need for an additional
 .75 classified ELL education assistant.
- Member Fischer-Maki made a motion to approve resolution (#01) to transfer contingency funds in the amount of \$50,000 to provide adequate staffing for the English Language Learner program. Member Wright seconded the motion; the motion passed unanimously.

Memorandum of Agreement – Three Rivers Education Association-HB 4030 Funds

- Deputy Superintendent Alderson again shared that these funds will be utilized for salary and compensation for our licensed staff and there is a shared vision between the association and district to offer mentors staff in their first, second or third year. When they feel supported, they will stay.
- Member Fischer-Maki made a motion to approve the TREA licensed memorandum of agreement. Member Wright seconded the motion; the motion passed unanimously.

Hidden Valley High School Scoreboard Agreement

- Superintendent Valenzuela presented a Mustang Softball Scoreboard Advertising Agreement for Hidden Valley High School and Evergreen Federal Bank. Evergreen will provide funding for the scoreboard in the amount of \$17,118 in exchange for exclusive rights to place the Evergreen logo on the scoreboard, for the life of the scoreboard.
- Member Wright made a motion to approve the advertising agreement with Evergreen Federal Bank. Member Fischer-Maki seconded the motion; the motion passed unanimously.
