Students, parents, staff and community members seem to have stronger and stronger opinions on board of education and administration decisions every day, but how far can they go in expressing those opinions? Can a school district remove a disruptive community member at a board of education meeting? Can administrators delete an offensive comment from the district's social media website? Should a citizen be banned from passing out information or obtaining signatures for a petition on a sidewalk in front of the school? Participants will leave with an understanding of First Amendment and other legal parameters for these decisions, and a plan for addressing disruption in a legally defensible manner.
