

SUBJECT: Announce board training completion requirements for the period covered by this announcement, May 1, 2025, through April 28, 2026.

BACKGROUND: Under State Board of Education Rule, completing required continuing education each year of service is a basic obligation and expectation of any sitting board member. The board president or the presiding officer are required to announce the name of each member who (1) has completed the required continuing education, (2) has exceeded the required continuing education; and (3) is deficient in meeting the required continuing education.

The requirements for training are measured as of the first anniversary of the date of the trustee's election or appointment or two-year anniversary of his or her previous training, as applicable. There are ten training areas for board member continuing education:

3. Open Government
4. Child Abuse Prevention – Sexual Abuse, Human Trafficking, and Other Maltreatment of Children

9. Team Building
10. Additional Continuing Education
