# Upcoming Changes to CCMR and College Prep Courses

College Prep Math	29.5%	15.7%
College Prep Reading	26.6%	1.3%
Both	20.2%	0.4%

TEA is limiting option for College Prep courses for the Class of 2027, and we anticipate it will have a large impact on state numbers as districts adjust.

LISD will see a slight impact beginning in 2028 since a smaller portion of our students meet CCMR through these courses.

# Continuing CCMR Discussions

- CCMR campus leadership meetings held to analyze data and discuss the following:
  - Progress with Class of '25
  - College and Career Readiness data as of now
  - Student completion needs by class
  - Beginning and Mid Year Campus Team meetings to look at progress and next steps (short and long term)
- TSI testing implementation as part of course completion for English 3 and Algebra 2
- Dual Credit Opportunities a focus for growth in courses with limited IBCs
- CTE program of study and completer alignment by feeder pattern with IBC identified with 1 pager overviews by HS, LHSK and LHSH will have full CTE program completion in 3 programs of study
- Middle Schools - CTE Explorations course launched at all middle schools, 2 HS CTE courses are offered at every middle school to start the path to program completion, TECC Tours for 8th grade in Fall

\*LISD Long Range Plan CCMR goals are about student engagement in an offering vs. state accountability which requires students to complete paths regardless of desire to continue in a course of study. State system serves to penalize for exploring new interests.

# STAAR TERMINOLOGY

- **Approaches Grade Level:** A student achieving Approaches Grade Level is likely to succeed in the next grade or course with targeted academic intervention.
- **Meets Grade Level:** Students at this performance level have a high likelihood of success in the next grade or course, but may still need some short-term, targeted academic intervention.
- **Masters Grade Level :** The TEA expects students at Masters Grade Level to succeed in the next grade or course with little or no academic intervention.

Recruit, retain, and develop the talents of dedicated teachers and staff to engage and inspire learners and leaders


Measure: Remain w/i top 25% of market group for turnover rate.

# Revenue


## 2023-2024 Actual Operating Revenue-All Funds
